Keywords are written under abstract in bold and italic formats and are the substance of the research carried out. # A. INTRODUCTION

The introduction contains the research objectives and the reasons for conducting the research. The main part of an article should begin with an introduction that provides further details about the purpose of the writing/research, motivation, research methods, and findings. The introduction should be relatively non-technical, yet clear enough for readers to understand the contributions of the article.

The template is designed to provide guidance to authors on the format or layout of articles published in Aljabar: Journal of Mathematics Education. Writers must adhere to writing rules, including font type, size, layout, word count, structure, and citation format. What is equally important is that the writing adheres to the Enhanced Spelling System (EYD) of the Indonesian language, using appropriate vocabulary and following.

scientific principles correctly and appropriately. If the article is written in Indonesian, then the article must use correct grammar and has been carefully proofread by a language expert. In addition, the writing must adhere to the ethics of scientific publication. The body of the article, including the bibliography, is written in a single column, as in this template. The first line of the first paragraph after the subheading is not indented (aligned with the subheading). In the following paragraph, the first line is indented by one tab. (0,64 cm). Typing articles will be easier when using Microsoft Word software. Use the page layout menu to determine the paper size used, which is A4, and set the margins or borders for the right, left, top, and bottom using the options. (That is: right 2 cm; left 2 cm; top 3 cm; and bottom 2 cm.). The line spacing is single without any additional space between paragraphs. The font used is Cambria size 12pt.

The writing system consists of an introduction, methods, results, discussion, and conclusion. The introduction contains the reasons for conducting the research supported by a literature review. (theoretical). The introduction section is written to be about 20% of the body of the article. Then, the methods section contains a brief description of the research methods used (approximately 10% of the body of the article). The next section is very important, namely regarding the results and discussion. This section is written to comprise about 65% of the overall article, and the discussion of the research results must refer to previous research findings. The conclusion is written concisely (about 5% of the body of the article) to provide a brief answer to the research problem. Meanwhile, the bibliography is written according to the guidelines issued by the American Psychological Association (APA) Sixth Edition published in 2010.

## **B. RESEARCH METHOD**

This section of the methods must explain the research methods used, including the location, timing of the research, and how the procedures were carried out. The tools, materials, media, or research instruments must be explained clearly. If necessary and important, there is an attachment regarding the outline of the instruments or excerpts of the materials used merely to provide examples for the readers. If there are statistical formulas used as part of the research method, it is advisable not to write down formulas that are already commonly used. For example, specific provisions set by the researchers for the purpose of collecting and analyzing research data can be explained in this methods section. Writers are advised to provide references for the methods used.

### C. RESULTS AND DISCUSSION

The results and discussion should be presented in the same section, clearly and concisely. The discussion section must contain the implications of the research findings, rather than repeating the results section. The results and discussion can be written in the same part to avoid extensive citations.

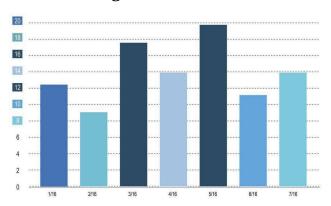


Figure 1. Bar Chart

This section provides examples of citation writing. Everything in this list can be traced within the body of this article template to study the proper way of writing citations in the text.
