3) Wrongful Death

No amount of monetary compensation can replace a life. However, losing a loved one causes many economic damages to the family, including medical bills as well as funeral costs. It sometimes compromises the financial security of the surviving family members.

Reasonable compensation can alleviate the burden associated with death due to someone else's negligent action. Our lawyers will fight for your loved one's justice and ensure you get fair compensation to help you move forward.

A wrongful death occurs when a person dies as a result of the negligence or misconduct of another person, company, or entity. It can be the consequence of a car crash, medical malpractice, use of dangerous or unsafe premises, negligent security, fire, or another fatal event.

Losing a loved one triggers grief, sadness, and sorrow. However, during this time of grieving, income may diminish and creditors are unsympathetic to your loss. 4) Product Liability

Food poisoning may not sound serious, but more than 3,000 people die each year after eating contaminated food, according to the Centers for Disease Control and Prevention (CDC). Hundreds of different kinds of bacteria may contaminate foods; while some are benign, you can contract serious infections like hepatitis A and E. coli from food. In some cases, there are no treatments for these foodborne illnesses. Worse, it is often difficult to identify the source of food poisoning without extensive testing. An item may pass through the hands of many different companies on the supply chain, including those based overseas. Consequently, a product liability lawsuit for food contamination is often incredibly complex and requires a lawyer with experience in this area of law.

Medical devices and implants like pacemakers, artificial joints, and defibrillators can vastly improve your quality of life and, in some cases, save your life. However, if medical devices contain product defects, they may fail or break, possibly causing more damage than the underlying conditions they are designed to treat. The companies that manufacture and sell implants and medical equipment must perform extensive tests to eliminate dangerous defects. Still, many companies neglect necessary tests, ignore negative results, and/or fail to remove products from the market once they are shown to be unsafe. If a medical device failure caused your injuries or a loved one's wrongful death, then you may be able to collect compensation from the manufacturer.

5) Medical Malpractice

Medication errors that are caused by a doctor or medical professional's negligence should be brought to a Washington DC, Virginia, or Maryland court. All damages that the negligence caused can be claimed in your case, and we will help you get the most compensation possible for your losses.

Common damages to claim in medication error cases include:

- **Current and future medical expenses** – Covering treatment, surgery, equipment, and other related medical bills.
- **Lost wages and future wages** – Reimbursement for income that is missed due to injury, plus earning potential that will be missed due to future treatment and ongoing injury.
- **Noneconomic damages** – Emotional damages, such as pain, suffering, emotional distress, physical disability, and more.
- **Wrongful death** – When a loved one has died from a medication error, the family can bring forth a wrongful death lawsuit when it was due to negligence.

6) Worker's Compensation
