### **Definitions**

For the purposes of this Privacy Policy:

- Cookies are small files that are placed on Your computer, mobile device or any other device by a website, containing the details of Your browsing history on that website among its many uses.
- Country refers to: Texas, United States
- **Device** means any device that can access the Service such as a computer, a cell phone or a digital tablet.

- To manage Your requests: To attend and manage Your requests to Us.

# **Bluetooth Connectivity**

#### **Data Collected**

We do not collect any personal or sensitive data through Bluetooth connections. The Bluetooth connection is solely used for audio transmission and device pairing.

#### **Data Security**

We prioritize the security of your data. While Bluetooth connections are inherently secure, we take additional measures to protect your privacy.

### **Retention of Your Personal Data**

The Company will retain Your Personal Data only for as long as is necessary for the purposes set out in this Privacy Policy. We will retain and use Your Personal Data to the extent necessary to comply with our legal obligations (for example, if we are required to

retain your data to comply with applicable laws), resolve disputes, and enforce our legal agreements and policies.

The Company will also retain Usage Data for internal analysis purposes. Usage Data is generally retained for a shorter period of time, except when this data is used to strengthen the security or to improve the functionality of Our Service, or We are legally obligated to retain this data for longer time periods.

## **Delete Your Personal Data**
