 - 5.3.1. This has become an issue because of the discovery that at least one dean has been discovered popping into Canvas online courses unannounced and without the instructor's permission. With new contract language this should only happen in an emergency and after they inform NFA of the urgency. Typically supervisors should get permission just as a traditional class, but the current settings allow them to not be detected. Web College



committee is currently discussing this and drafting language for a policy to go through the Faculty Senate and the Planning Committee to get approved as an official TMCC Policy.
