Privacy Policy

Picatrebax built the **Fatty Fish** app as a Free app. This SERVICE is provided by Picatrebax at no cost and is intended for use as is.

Log Data

Picatrebax wants to inform you that whenever you use our Service, in case of an error, the app collects data and information (through third-party products) on your phone called Log Data. This Log Data may include information such as your device Internet Protocol (“IP”) address, device name, operating system version, the configuration of the app when utilizing my Service, the time and date of your use of the Service, and other statistics.

Cookies

Cookies are files with a small amount of data that are commonly used as anonymous unique identifiers. These are sent to your browser from the websites that you visit and are stored on your device's internal memory.

This Service does not use these “cookies” explicitly. However, the app may use third-party code and libraries that use “cookies” to collect information and improve their services.
