# **Gifted and Talented Honors Dance**

The Gifted and Talented Honors Dance Program is designed to develop the artistry that is within every dancer. The program teaches the fundamentals of dance, the rudiments of proper alignment, strength, flexibility, and balance. Students will learn elements of ballet, modern, jazz, improvisation, dance history, choreography, and lighting. Students will also have an opportunity to dance as part of the Repertory company and the Tap Co. that tour Somerset County. Fourth year students will have the opportunity to create, choreograph, light, costume, and present an original group dance work. Students graduate with a certificate verifying their dance training as well as a certificate in Beginner Mat Pilates. An audition is required to be selected for this highly competitive program. The Dance program has an articulation agreement with Raritan Valley Community College for Ballet 1 and Ballet 2.

#### Curriculum:

Year 1: Dance Fundamentals: basic terminology, correct body alignment, time, space, energy/force and shape

Year 2: Dance Technique: continuing training in Ballet, Modern, Tap and Jazz dance techniques, dance pedagogy


Year 3: Dance Expression: integration of dynamic alignment, choreography, and composition, teaching methods

Year 4: Emergence & Career Development: dynamic alignment, correct technique, artistic interpretation, and production

The Repertory Company invites a New Jersey professional dance artist to set a dance work for the company. All students are invited to participate in the company's work. Dancers are given the opportunity to present the work in various theaters across the state and at our County Teen Arts Festival. The company's goal is to expand the concert dance performance experience for all that are interested in additional work outside our curriculum.



Through the National Dance Education Organization (NDEO) & Dance New Jersey, SCVTHS students (grades 11 & 12) may apply for the National Honor Society for Dance Arts.

Eligibility Criteria for Student Induction into the NHSDA Secondary Program is earned through the accumulation of 30 points\* (one point for every 45 hours) awarded for dance activities such as dance classes, rehearsals, performances, research, workshops, or community service activities, alongside a GPA of at least 3.0.
