Dear Parents of MHHS Seniors and Juniors,

The **MHHS Seniors and Juniors** are eligible to participate in our Off-Campus Lunch Hour. With the school's extended lunch hour and the close proximity of our homes, students have enough time to leave campus for lunch and be able to return in time for classes. Please review the requirements, restrictions, and consequences listed below. If you wish for your student to participate in Off-Campus Lunch, you may return the signed consent for your student. Only students with signed consent forms may leave campus during lunch.

Requirements:

- Must be a Senior or Junior
- **Starting next Wednesday, August 18th. Students need to have selected off-campus lunch for their SUCCESS! Activity.**
- **If you are assigned to a SUCCESS Activity by a teacher, you must attend your assigned period and not off-campus lunch.**
- All drivers must have a valid driver's license.
- Must sign out at the parking lot gate near the MPR prior to leaving for lunch.
- Must sign in when returning to campus in the administration building.
- Need a signed consent form for off-campus lunch.
- All seniors and parents acknowledge that while a senior is off-campus during lunchtime, they are subject to school rules and discipline.

Restrictions:

- May not take lowerclassmen off-campus.
- Must have the appropriate amount of credits to graduate.
- Must be back on time every day.
- May not have had a suspension.
- May not visit other school campuses.
- May only leave campus within the first 20 minutes of lunch.

- May not bring outside food back to campus for other students.
- May only be off-campus for lunch and must be on campus for Flex period if they have 4th or 5th-period Flex.

Consequences:

- Right to off-campus lunch can be suspended for a week after being tardy one time.
- Right to off-campus lunch can be suspended for one month if tardy for a 2nd time.
- Right to off-campus lunch can be revoked permanently if tardy for the 3rd time.
- If caught ditching, there will be a permanent revoke of off-campus pass.
- Any other violation of the requirements and restrictions may result in losing off-campus lunch privilege.
