Club Resourced Independent Bay Swim (CRIBS) Application

General Guidelines

1. This form must be submitted and approved at least 1 week before your swim.
2. All swimmers and pilots must be current DC members in good standing.
3. All swimmers must be qualified for out-of-cove swims and be current members of USMS.
4. All pilots must be qualified for their craft and be current members of USRowing.
5. The maximum number of swimmers is 8.
6. The ratio of pilots to swimmers must be 1:1—each swimmer must have a pilot.
7. Cross-channel swims always require at least 1 motorized craft, and a qualified cross-channel lead pilot.

The Lead Organizer is responsible for planning a safe swim, and must have an understanding of each swimmer's abilities and limitations. The Lead Organizer must recruit a Lead Pilot and establish a pilot team capable of managing any challenges that may arise during the swim. Do not submit this form without a Lead Pilot commitment.

The Lead Pilot is responsible for conducting a safe swim, and must have an understanding of each swimmer's and each pilot's abilities and limitations. It is the responsibility of the Lead Pilot to inform Vessel Traffic before the swim begins and keep them apprised of progress and completion. Vessel Traffic monitors VHF Channel 14. The Lead Pilot must have a VHF radio turned on to Channel 14 at all times during the swim. Vessel Traffic's phone number is (415) 399-7410.
