

Privacy Policy

In this privacy policy, we, Anna Pavlushina, outline how we collect, store, use, and share your information when you use Package Tracker - Track Parcel.

WHAT INFORMATION DO WE COLLECT?

- Personal Information:

We collect personal information that you voluntarily provide to us when expressing interest in obtaining information about us, our products, and Package Tracker - Track Parcel. This includes your participation in Package Tracker - Track Parcel or when you contact us.

- Sensitive Information:

We do not process sensitive information.

- Application Data:

If you use Package Tracker - Track Parcel, we may collect additional information with your permission, such as accessing features on your mobile device (e.g., camera, storage, photo albums). You can manage these permissions in your device's settings. We require this information primarily to ensure the security and functionality of our application(s), for troubleshooting purposes, and for internal analytics and reporting. It is essential that any personal information you provide is accurate, complete, and truthful, and you must inform us of any changes to such information.

HOW DO WE PROCESS YOUR INFORMATION?

We process your information to provide, enhance, and administer Package Tracker - Track Parcel, communicate with you, ensure security and prevent fraud, and comply with legal requirements. With your consent, we may also process

your information for other purposes. **Protection of Vital Interests:** In situations where it is necessary to protect an individual's vital interests and prevent harm, we may process your information.

WHAT LEGAL BASES DO WE RELY ON TO PROCESS YOUR INFORMATION?

We process your personal information based on valid legal reasons (i.e., legal bases) under applicable law. These reasons include your consent, compliance with laws, fulfillment of contractual obligations, protection of your rights, and pursuit of our legitimate business interests.

WHEN AND WITH WHOM DO WE SHARE YOUR PERSONAL INFORMATION?

In Short: We may share information in specific situations described in this section and/or with the following third parties.

We may need to share your personal information in the following situations:

Business Transfers. We may share or transfer your information in connection with, or during negotiations of, any merger, sale of company assets, financing, or acquisition of all or a portion of our business to another company. ***Business Partners.*** We may share your information with our business partners to offer you certain products, services, or promotions.

HOW LONG DO WE KEEP YOUR INFORMATION?

In Short: We keep your information for as long as necessary to fulfill the purposes outlined in this privacy notice unless otherwise required by law.

We will only keep your personal information for as long as it is necessary for the purposes set out in this privacy notice, unless a longer retention period is required or permitted by law (such as tax, accounting, or other legal requirements).

When we have no ongoing legitimate business need to process your personal information, we will either delete or anonymise such information, or, if this is not possible (for example, because your personal information has been stored in

backup archives), then we will securely store your personal information and isolate it from any further processing until deletion is possible.

DO WE COLLECT INFORMATION FROM MINORS?

In Short: We do not knowingly collect data from or market to children under 18 years of age. We do not knowingly solicit data from or market to children under 18 years of age. By using Package Tracker - Track Parcel, you represent that you are at least 18 or that you are the parent or guardian of such a minor and consent to such minor dependent's use of Package Tracker - Track Parcel. If we learn that personal information from users less than 18 years of age has been collected, we will deactivate the account and take reasonable measures to promptly delete such data from our records. WHAT ARE YOUR PRIVACY RIGHTS?
