- 1) Bank in HKD1,000 refundable deposit to Merlyn Healthcare Ltd and mark reseller full name at payment/sender remarks.

Dealer terms and conditions:-

- 1) Dealers are required to pay HK\$1,000 deposit for dealer account setup, the deposit will be refunded at month-end 30 days after the dealership termination.
- 2) Dealer should comply with all Merlyn Health pricing policies and sales conditions, false prompt, selling, and violations of laws are subject to penalty and termination of the dealership.
- 3) Direct Selling Commission and Override Commission will be pay at month-end 30 days, if the first month of account opening is less than 20 days, the settlement will be extended to the second month.
- 4) Merlyn Health has the right to terminate the dealership if the dealer sales volume of the direct selling is less than 30 products or less than 6 override accounts in the first 3 months.
- 5) All commissions will be calculated at after-sales tax and discounted net price.
- 6) Merlyn Health has the right to decline dealer and its referral application.

Potential earnings:-

Dealers will make a total 4225.5 per month (ie. direct selling commission 1408.5 per 30 products average price 313 per month, and 2817 per **3 referrals**, each referral sells 30 products average price 313 per month).

Dealers will make a total 7042.5 per month (ie. direct selling commission 1408.5 per 30 products average price 313 per month, and 5634 per **6 referrals**, each referral sells 30 products average price 313 per month).

Dealers will make a total 9859.5 per month (ie. direct selling commission 1408.5 per 30 products average price 313 per month, and 8451 per **9 referrals**, each referral sells 30 products average price 313 per month).

Remarks:-

- 1) All products are 100% manufactured in U.K.
- 2) All transactions will be Hong Kong-based, and all commissions will pay in Hong Kong, but overseas payment could be considered, subject to bank charges.
- 3) Merlyn Health will be responsible for the U.K. 20% sales taxation.
- 4) Potential earning is forward thinking estimation without prejudice and guarantee.
- 5) Merlyn Health will provide marketing materials and videos for dealer use.
