Course codes for APAA Courses ONLY

Advanced Placement Access for All (APAA) course codes have been developed to ensure districts have accurate records for accountability and funding. The codes below should only be used for students who are taking virtual APAA courses through the Niswonger Foundation. Students taking AP courses at their local school (within the classroom with a local teacher of record) should remain enrolled with the regular AP course codes. Do these courses count as substitutions for Core Graduation requirements?

Yes, many of these courses will substitute for a core graduation requirement. Please see the most up-to-date TNSBOE approved high school course offerings list to understand course substitutions.

How do we put in Teacher of Record (TOR)?

EIS Administrators should put in the APAA Course code for each APAA course and when prompted to give a Teacher of Record, click NO. If your SIS/EIS does not give this option or requires more information, then you need to speak with the person at your system that oversees this, the SIS vendor, and/or your TDOE contact.

All APAA teachers are licensed TN teachers and the department has access to all current and former online APAA teachers for their review.

What date do we use for the enrollment date?

The first day of school for your high school should be the enrollment/ start date for these courses in your SIS/EIS.

Should we enter all of these courses into our system?

You should only enter the course codes for APAA courses being taken by your students.

Is there a limit to the number of students in a course?

Class size limits set by the State Board of Education are followed in the APAA program.

Who will create these courses in our system?

Your EIS coordinator, SIS Specialist, and/or designated school administrators should work together to create these courses for your master schedule.

How do we know which students to enroll once we have the courses in our SIS?

AP Liaisons will use their APAA GeniusSIS account to see all students who are enrolled in a Niswonger Online APAA course. Students who are given time during the school day to work on their online AP course should now be given the course codes listed above.

How do we assign final grades to students working on an AP course outside of the school day?

Students who have a full schedule at their school and are working on their online AP Course outside of the school day will be given a transfer credit at the end of the year using the course codes above or, if your system allows, can be assigned a 5th period/9th period (depending on your set-up of yearlong or block scheduling).

If a school system allows additional periods within their EIS (for example a school on block allows a 5th period to be placed on the transcript) then this should be done so the course shows on progress reports

as the student is working. This is especially important for seniors who are taking an AP course in their fall semester and want it to show on their current enrollments when applying to colleges.
