EXECUTIVE ORDER N° 24

Safeguarding Fremont and the United States of America from illegal immigration

January 6th, 2022

IN PLAIN ENGLISH

(This section does not constitute a part of the Order)

This Executive Order is designed to defend and safeguard the Republic of Fremont and the United States of America as a whole against illegal immigration and reduce the number of illegal aliens in the United States of America.

To the People of Fremont, Greeting:

WHEREAS, the privilege of residency in the United States of America can be obtained in a legal and fair manner through the proper processes,

WHEREAS, those unwilling to follow the correct laws and processes regarding immigration to the United States of America do not deserve the privilege of residency in the United States of America,

WHEREAS, it is the duty of the government of the Republic of Fremont and of the Governor to ensure that the law — including the law with regard to immigration — is correctly executed,

NOW, THEREFORE, I, MICHAEL D. GRANT, Governor of the Republic of Fremont and in accordance with the authority vested in me by the Constitution and statutes of Fremont, do hereby order as follows:

Sec. 1. ENSURING PROPER RESPONSE TO ILLEGAL IMMIGRATION BY LAW ENFORCEMENT.

1. It is hereby ordered that the Republic of Fremont and any County Sheriffs are to fully cooperate with all Federal Immigration Authorities and ICE officials in the execution of their duties.
2. It is hereby ordered that any law enforcement officer or public official who actively seeks to undermine the execution of federal immigration law by either state or federal law officials shall be warned, with two offenses resulting in an immediate suspension no greater in duration than 3 months, and with three offenses resulting in an immediate termination of their position.

Sec. 2. SANCTUARY ZONES.

1. Any city, county, or local municipality officials in the Republic of Fremont shall not offer protection to illegal aliens against State Law Enforcement or ICE.
2. Any city, county, or local municipality officials in the Republic of Fremont shall not offer any aid or assistance to illegal aliens in evading State Law Enforcement or ICE.
3. If any city, county, or local municipality enacts local ordinances violating Section 2 Clause 1 or Section 2 Clause 2, both of this order, I order the Fremont Department of Transportation to withhold funding related to roads and transportation until a time when such ordinances are rescinded. The Governor of Fremont shall retain the power to rescind this order if they feel that the withholding of funding is detrimental to surrounding cities, counties, or municipalities that are not in violation of this order.
4. If any city, county, or local municipality enacts local ordinances allowing Section 2 Clause 1 or Section 2 Clause 2 to occur, it will be formally requested by the executive department of the Fremont state government that such ordinances be rescinded. This request shall be delivered automatically as a physical letter to the relevant officials. A copy of any such letters sent is to be retained by the Office of the Governor for record-keeping purposes.

Sec. 3. EXCEPTIONS.

1. The procedures of Section 1 and/or Section 2 shall not be enforced if the illegal immigrant relevant in Section 1 and/or Section 2 is considered to be arriving from a nation in which there is a situation of extreme danger.
2. The definition of "situation of extreme danger" shall be defined as a situation in which there is a significant threat to life, liberty, and pursuit of happiness. This definition may be altered at any time.
3. The nations mentioned in Section 3 Clause 1 include but are not limited to: Venezuela, the Democratic People's Republic of Korea, the Russian Federation, the People's Republic of China, the Islamic Republic of Iran, and the State of Libya.
