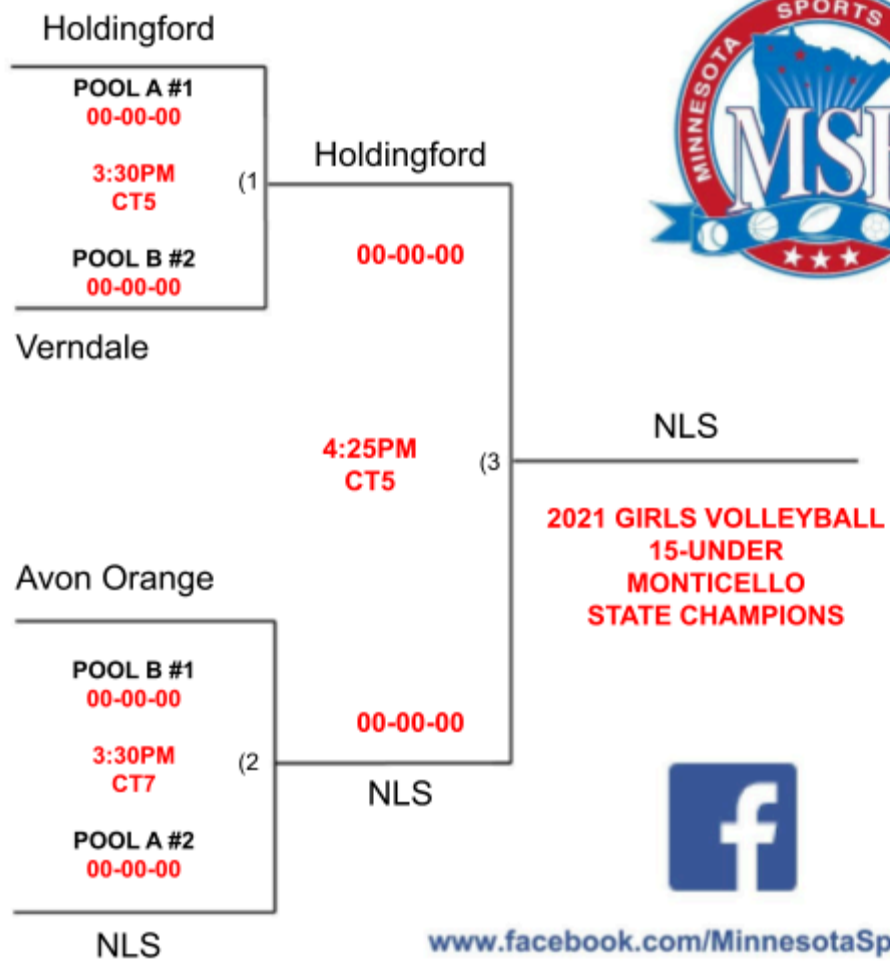
TOURNAMENT SPECIFIC INFO

1. Pool Play in Pool A is two game sets to 15 points each with a 17 point cap and in Pool B two game sets to 25 points with a 27 point cap.
2. First and second place teams in each pool advance to the championship bracket with third and fourth place advancing to the consolation bracket. Fifth place pool teams do not advance.
3. Fifth and sixth Place teams in pool play do not advance.
4. All pool play results count, unless there is a forfeit, in which case all results of the forfeiting team are canceled.

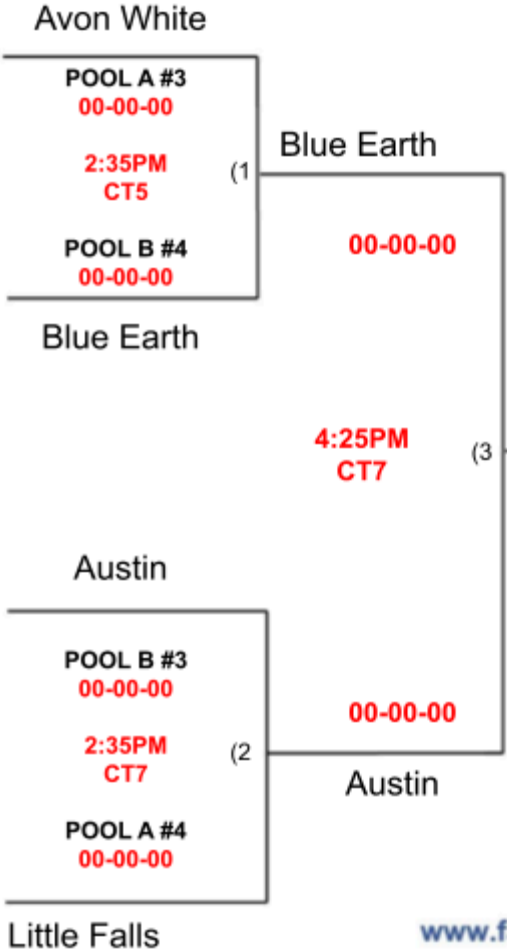
