- Not nearly enough demand to justify spending this much

Will talk about cuts, and come back with a revised budget

Open Forum

Chandler is taking the semester off, discussion regarding the responsibility of his roles including funding, voting, planning, etc.

EC's will be splitting up his roles

(Thomas)

- There is no one written in constitution about someone stepping in to take hold of funds
- Really difficult for us to just suddenly appoint someone
- Perhaps a yay or nay vote of Board regarding weekly student activities expenses?

(Whit) a lot of the reimbursements go through Treasurer and CFO

- Maybe have a smaller committee just to check and push through reimbursements
- Possibly Sami, Julian, EC,

(Alanna) I think that Josh has been in the GC the whole time, already in the loop about everything, perhaps should just take that on since he is already in that sort of position

• (Josh) agree

(Tanvi) Just throwing in CLee's name...?

• (Julian) CLee has already been brought in as an adviser for now!

(Thomas) If Josh were to step in, it would be

(Chloe) To the EC's - how much more responsibility are you having to take on? Their hours will get capped out eventually and won't get paid for work they're doing

- No one to guide us with budget, really need help with that
- Blind leading the blind
- Clee has been a lot of help

(Thomas) special stipend of \$100 can be issued

(Josh) totally makes sense to have a check on the finance side of things

- (Whit/Thomas) having a bit of a committee working on it too may be better
- Josh and Patrick and Whit NEW DREAM TEAM YAY (for financial side/reimbursements)
 - Student Activities Fund and Alternative Programming Fund = approx \$30,000 left plus WP (\$28,000) and McKenna Palooza (\$15,000)

What about the Discretionary fund?

- \$1.200
- We'll just all have to vote on D.F., not going to just put it all into GF, that doesn't make sense (Maya) let's talk in the future about constitutional changes

(Thomas)

- Linkedin message from university in MN about "Ban the Box" regarding disclosing criminal record prior to application being read ends up being racially discriminatory in application process,
- Something to be considered and raised w/ the discrimination
- Question is still asked, just not until after the fact about an initial decision
- (Bryan) maybe a good senate conversation
- Julian works closely w/ admission, will look more into this
