## NAI-SINV COMMISSIONS TERMS OF SERVICE



## **GENERAL**

- ★ I'm free to refuse a commission for any reason.
- ★ You must apply your commission via the google form provided.
- ★ I may charge extra for particular details/complexity on the commission, I'll let you know if that's the case.
- ★ English is not my first language, so clear and straightforward communication is appreciated.
- ★ I may charge extra on NSFW commissions that contain certain subjects, these will be discussed personally.
- ★ Certain coloring styles offered in the SFW commissions might not be available for NSFW commissions and vice versa.

## **COMMISSION PROCESS**

- ★ Payment is done upfront via Paypal Invoice.
- ★ I will start the drawing once I have received the payment.
- ★ There will be no refunds once the payment is made, except, if for any reason I can't finish the commission, you will receive a total refund.
- ★ You must provide image reference(s) of the character(s) and/or particular props/clothing you want me to do, I will not accept textual descriptions. Except on character reference sheet commissions.
- ★ After I start your commission, I'll send you WIP's for your approval and to make the changes you desire.
- ★ During the sketch phase you'll have the right to do major changes (change pose, perspective, scenario, expression...), after that, during the coloring phase, you'll only be able to do small changes (change color, contrast, small details, adding filters...).
- ★ For major changes to advanced/finished commissions you'll be charged extra.
- ★ I'm free to refuse major changes to advanced/finished commissions.
- ★ If you're planning on printing your commission, it's important that you tell me so I can provide you with a file that has the appropriate color profile.
- ★ After the service is done, you'll receive .png and .tiff files of your commission via email or any other medium that lets me send uncompressed files.
- ★ I don't have an estimated time for completing commissions, but it's my responsibility to keep you updated on any delays.

## COPYRIGHT, USAGE AND PUBLISHING

- ★ By commissioning me you confirm that you have the right to use the characters you provide (either if they are from your authorship or you have consent to use them), except for popular characters (which can be considered fanart).
- ★ You can not claim the authorship of the artwork as your own. I retain all rights to it.
- ★ You are not allowed to remove signatures from the product that proves authorship.
- ★ The product is for personal use only, you are not allowed to use the artwork commercially.
- ★ You are allowed to repost the artwork as much as you want, preferably giving credits to me.
- ★ I'm free to decide to post the artwork in my personal accounts, unless you prefer to keep it private.
- ★ You have the right to remain as an anonymous commissioner if I publish the work in my personal accounts and you choose to do so.
- ★ You are not allowed to use the artwork to any extent in relation to NFT, Blockchain or machine learning (AI).
