[1] Article 3i Paragraph 1 of Regulation (EU) No 833/2014 concerning restrictive measures in view of Russia's actions destabilising the situation in Ukraine, as inserted via COUNCIL REGULATION (EU) 2022/576 of 8 April 2022, states that "it shall be prohibited to purchase, import, or transfer, directly or indirectly, goods which generate significant revenues for Russia thereby enabling its actions destabilising the situation in Ukraine, as listed in Annex XXI into the Union if they originate in Russia or are exported from Russia". When initially passed in April 2022, Annex XXI included HS Code 44: Wood and articles of wood, as well as HS Codes 4705 (certain types of wood pulp), 4804 (certain types of paper) and 9403 (furniture, including wood furniture). It was later amended to include all other types of pulp and paper and wooden seats. The EU defines the origin of a product as the country where it was produced or manufactured (as defined in the EU rules of non-preferential origin), not where it was shipped from. Assuming similar harvesting through 2024, and an average yield of one cubic metre of commercial timber per tree, gives an estimate of 100 million trees which would otherwise have been cut by the end of 2024 had logging rates remained unchanged.
- [72] In relation to EU sanctions on wood from Myanmar, a court in the EU recently ruled that customs authorities can require "supplementary evidence" when presented with origin documents, in cases where they have serious doubt about the veracity of origin claims.
- [73] Initially steel, like wood, was only banned if it was manufactured in Russia. In October 2022, however, as part of the 8th package of sanctions, Council Regulation (EU) No 833/2014 concerning restrictive measures in view of Russia's actions destabilising the situation in Ukraine was amended with the addition of Article 3g, which further prohibited the import of steel products "when processed in a third country incorporating iron and steel products originating in Russia". In October 2022, the steel import sanctions were further tightened through a requirement for importers to provide proof of origin of their steel products.
