Intro:

This page tells you the terms and conditions on which we will supply to you services/products (Products) listed on our website www.divineenergyinternational.com (our site) via one of our subscription services (Services). 1. YOUR STATUS

By placing an order through our site, you warrant that: 1.1 you are legally capable of entering into binding contracts; and 1.2 you are at least 18 years old.

2. HOW THE CONTRACT IS FORMED BETWEEN YOU AND US

- 2.1 After completing signup, you will receive an e-mail confirming your Membership. Your subscription constitutes an offer to us to buy Products by subscribing to a Service. We will confirm such acceptance to you by sending you an e-mail that confirms that your subscription has been accepted (Welcome Email). The contract between us (Contract) will only be formed when we send you the Welcome Email.
- 2.2 The subscription plan to our Services consists of an initial charge and then followed by recurring period charges as agreed to by you. By entering into this Agreement, you acknowledge that your subscription has an initial and recurring payment feature and you accept responsibility for all recurring charges prior to cancellation. Divine Energy International Ltd (DEI) may submit periodic charges (e.g., annually) without further authorisation from you, until you provide prior notice that you have terminated this authorisation. To terminate your authorisation or change your payment method, log into your Membership Account and manage your automatic subscription payment to us; we cannot alter or cancel this for you.
- 2.3 By subscribing to our Services you are agreeing to pay recurring periodic subscriptions for an indefinite time until cancelled by you, on the subscription terms set out in the application form you have completed. You can cancel your subscription at any time. You can re-subscribe at any time following your cancellation, but we reserve the right not to permit re-subscription.
- 2.4 Account Cancellations. If you wish to cancel your monthly subscription, you must cancel 21 days before the next collection date, if not this may result in being invoiced for the following year's benefits.
