New Business

Legislative Update

The session adjourned May 7, 2025. At total of 657 bill were introduced with 76 additional resolutions and memorials. 383 of these were passed. 228 bill have been signed by the governor. Any bills not acted on by June 6 become law.

OIT will deliver the first Tech Debt Report in Nov. 2025. In the next year, we will see a tight budget environment and we are continuing to explore impacts to IT and potential efficiency measures. The next session will convene Jan. 14, 2026

Data Inventory & Catalog Update

BHA has gone live. Work continues to onboard CDOT, DOR, DPA and CDPHE

We have begun planning for Agency Post Project Support. We intend to set up communities of practice to encourage knowledge sharing and ensure ongoing support. We will also continue to work on continuous data governance improvement. We will look to support the Enterprise data classification work. We will also be working on establishing the processes to enable Informatica as a service. Most immediately we are working on internal team training and preparation for the end of the project.

SLDS Update

HB25-1308 was sent to the Governor for signature. It mandates a new Sept 2026 due date for the first annual report. We are actively evaluating vendor proposals for the system build anticipating a contract in place by July. We are working on SLDS Architect onboarding this month. We have governing board approval of the MOU and DSA template. The next Governance Board Meeting is June 27. We will seek approval in substantial form of the complete legal framework (MOU, DSA, Policies). We plan to revisit the Research Framework. The Advisory committees are actively working on data governance data policies and procedures which were introduced at the Governing Board meeting May 16.

Data Classifications

We have been working on developing definitions to ascribe to the standard data types and classifications.

AGO has suggested changes to definitions, including to the GDAB approved definition of PII. There is a question of if the data breach legislation is included in PII definition. We will seek clarity from AGO. Should the proposed definition of PII be preferred, we would ask GDAB to update their definition so we had consistency. We are working on presenting these definitions to the HR Community and the Deputy Directors.

AI Dialogues

We are offering a a no-cost AI Literacy opportunity for state agencies to build foundational AI literacy, Support responsible use of Gemini for Workspaces (the only enterprise-wide approved productivity for official use at the state), foster a culture of responsible AI use and community AI learning. It will be available to 10 agencies on a first-come, first-served basis. The program includes tailored sessions for Executives (big picture context, Gemini skills and leadership), Operational Managers (governance, use cases, momentum) and End Users (Gemini skills, responsible use) and will support agencies in setting up a Community of Practice (culture-building and continuity).
