Coach's Update

- *Mileage Incentives*—Coach Smith would like to provide different items for each mileage incentive so that runners could collect “a set” of incentives (i.e. socks, t-shirt, sweatshirt...or a sweatshirt with different patches that could be earned...). Many possible ideas were discussed. Coach will discuss with the captains before a decision is made.
- *Assistant Coaches*—Coach Sheridan will be an assistant coach this fall and ideally the team would have a second assistant coach so there is always one at practice. The school will pay for a 1.0 position. Each assistant coach would be .6 so the AHS XC Booster will cover the remaining .2—see proposed budget. Coach Smith shared that Molly Libra (former assistant coach for Girls XC) may be interested.

- *Needs*—There are no large equipment needs but he may need to purchase a few more resistance bands for strength training.

Treasurer's Report

- Paul provided an overview of the 2025-2026 Budget closeout and the proposed 2026-2027 proposed budget.
 - The Booster Club ended 2025-2026 in a strong financial position due in part to fundraised monies received from businesses.
 - There was a brief discussion about potential fundraisers for the upcoming year.
 - There was discussion about small incentives for runners—there is room in the budget to accommodate this.
 - Paul will assist Sara L'Heureax as she transitions into the Treasurer position.
