 - Offer research-based curriculum that supports best instructional practices to improve student achievement. The curriculum is based on defined expectations set forth in the College and Career Readiness Standards.
 - Provide high quality curriculum and instruction by reviewing and analyzing assessment data to determine students' strengths and areas of focus and plan to provide a high quality education for academic success.
 - Provide students various opportunities to demonstrate academic excellence, including enrichment classes to enhance support of the student.
 - Offer an extended-day program for tutoring and extracurricular activities.
- 2. Hold parent-teacher conferences during which this compact will be discussed as it relates to the individual child's achievement.** Specifically, those conferences will be held:
 - Conferences will be held multiple times throughout the school year, at times convenient for both parents and teachers.
 - Conferences requested by either the parent or teacher, will help create a plan to support students through the MTSS process.

 - Progress reports will be issued at mid-term of each grading period.
 - Powerschool Parent Portal passwords and log on information will be distributed throughout the year so parents/guardians can get updated information on their child's attendance, grades, and discipline.

- Report cards will be distributed to students after the end of each grading period.

4. Provide parents reasonable access to staff. Specifically, staff will be available for consultation with parents as follows:

- *Staff can be accessed anytime via email or by calling the school to leave a message.*
- *Parents have an opportunity to meet teachers during open house and other school events.*
- *Parent conferences can be scheduled through the school office and will be coordinated and facilitated by our interventionist, with support through MTSS to create a plan that promotes student success and achievement*

5. Provide parents opportunities to volunteer and participate in their child's class, and to observe classroom activities, as follows:

- *Parents are welcome to volunteer their time whenever available with a background check on file.*
- *Parents may volunteer to chaperone for field trips with a background check on file.*
- *Parents may also visit the school at any time for a classroom visit, other than when district assessments are being administered.*
- *All guests must pass through Raptor visitation management system by submitting an approved government issued ID.*

6. Ensure regular two-way, meaningful communication between family members and school staff, and, to the extent practicable, in a language that family members can understand.

- *Parents are able to communicate effectively with our school staff directly, or by providing documents which can be translated in effort to obtain assistance.*
- *The region's appointed English Learner Specialist helps to provide additional tools that will help with translation to aid in communication efforts.*
