 - Volunteers

 - Stephanie suggested that Madison attends Richie Weaver's meeting to talk to high school coaches
- Grants and Scholarships Stephanie
 - Hallowheel had a great weekend, 150 players, GBRCTA gave \$600 in compliance with GBRCTA guidelines (we are a presenting sponsor)
 - Hallowheel raised \$68,000
 - Rusty discussed the success of Hallowheel 2023
- Treasurer's Report Rodney
 - Rusty mentioned that Rodney will be a representative for LTA Region 2 representative
 - There is no requirement for Rodney to leave GBRCTA
 - October financials
 - Spent CGPG money by October, which is a record
 - Been in contact with Kyle Jackson tournament
 - Using our paypal account to collect fee, sponsorships are covered (\$10,000), so every entry fee will go to us
 - CGPG money was submitted by Rusty, we will get about \$12258 in 2024
- Executive Committee Rusty
 - BREC: November 27, follow-up with GBRCTA community and pickleball community

- Everyone will be invited
- BREC will share an overview of process
 - USTA will give \$100,000 each phase. If it's done all at once, BREC will only get one lump sum of \$100,000
- LTA CTA meeting on December 1, 2
 - Meeting for CTAs around the state, at Renaissance Hotel
 - Only way to get CGPG money is to attend
- No reports for marketing, grassroots, volunteer recruitment
- Open floor to new business
 - Does GBRCTA want to have a table at Bellas?
 - Lesley asked to use GBRCTA tents
 - Stephanie brought up re-starting up Community Cup, would this be something that the executive board needs to decide
 - Hunter also wanted to have Tennis Apprentice, wants to train someone at another facility
 - LTA gives racquet for free, only need pros for a few weeks, players party not expensive, made about \$2800
