There are few works that directly connect ecology and the study of Confucianism. However, there is a growing body of literature that provides insight into the cultural, philosophic, historic, economic, and religious elements of Confucianism that do bear upon any consideration of a modern ecological worldview. This bibliography is divided into two parts: texts specifically related to the topic of Confucianism and ecology and general, supportive reference works (by region) for understanding the larger context of Confucianism and ecology.
