ABSTRACT ← 11pt, bold, italic, centre

A paragraph of about 200-250 words without indentation of the first line and written in one paragraph in TNR-10. We strongly encourage authors to use the following structured abstracts: Background: explain the gap analysis of this study (about 1-2 sentences) and highlight the purposes of the study; Methods: briefly describe the main methods applied, including samples/participants, instruments, collecting data technique, and analyzing data technique; Results: summarizing the research findings, should be in line with the purposes of the study; Implication: briefly describe the impact of your study. The abstract should be an objective representation of the article. It must not contain results not presented and substantiated in the main text and should not exaggerate the main conclusions.

Keywords: keyword 1, keyword 2, keyword 3 (maximum 5 keywords alphabetically, no abbreviation, and separated by coma (,)). ← 10pt. (the space between the last sentence in abstract and keywords is 4pt)

Introduction ← 12pt, bold

The introduction must contain clearly explanation of 1) issue background related to research, 2) previous research related to the issue presented; explain the gap between previous research and conducted research, 3) describe the novelty or the gap of conducted research is supported by relevant theories from primary sources, and 4) explain how focus the focus of the research is carried out; the solution of the concerned problem. Authors can write the purpose or the research problem descriptively in the last paragraph of the introduction part by not using bullets and numbering.

The style and size font use TNR 11pt, space 1,5, and justified paragraph. Every single word in first paragraph must be indented inside 1 cm. The citation must be used citation management with APA style 7 version. One and two author(s) should write the last of their name, then the reference year. If the authors are three or more, write the first author's last name and et al. then the reference year. For example, one author should be written (Siahaan, 2023) and for two authors should be (Siahaan & Mone, 2023) yet for more than two authors should be (Siahaan et al., 2023). In case, there are two or more references must be written (Siahaan, 2023; Son & Deda, 2022; Mone et al., 2021).

The manuscript will be prioritized to be processed that in line with focus and scope of Range: Jurnal Pendidikan Matematika. In addition, the manuscript strongly free of plagiarism indication which proved the level of plagiarism result is maximum 20% by Turnitin app and 15% by plagiarism checker app. The manuscript will be 10-14 pages.

Methods ← 12pt, bold

The method is written in TNR-11 and space 1,5. Every single word in first paragraph must be indented inside 1 cm. This part must contain the type of research, time and place of research, research participants/subjects, design, procedures, instruments and data analysis techniques as well as other matters related to the research method. Some of the important things above are narrated in several paragraphs, not in sub-section form.

Methods should be described with sufficient details to allow others to replicate and build on the published results. This section explains the research design, the reasons for the design, the research procedures applied, the population and research samples or participants, research instruments, data collection techniques, and data analysis techniques. The description should be in the past tense.

Results and Discussion ← 12pt, bold

Research and discussions are written in TNR-11, with 1.5 space. Every single word in first paragraph must be indented inside 1 cm. The results and discussion are not presented in the form of separate sub-chapters, but in a single sub-chapter "**Results and Discussion**". Therefore, these two parts are presented together, by presenting the research results first, then followed by a discussion of the research results. The research results are presented in the form of quantitative and qualitative data according to the research objectives. If there is more than one research objective, then the presentation of the results and discussion are also adjusted to the research objectives. Present research data according to the first objective, accompanied by discussion. The next section is the presentation of research data according to the second objective, accompanied by discussion, and so on.

This section contains approximately 40% of the entire manuscript. Research results are presented in the form of graphs, tables, or descriptively. Analysis and interpretation of these results is necessary before discussion. It is suggested that one table or figure does not exceed one full page. The way to presented table like this following Table 1.

Table 1 shows that the number and the name of table are positioned at the top of the table. Table numbering is bolded and italicized, but table names are only italicized. The word in the first row is bolded, but this does not apply to other writing. Both numbering, names and table contents use TNR 10pt type, single space, with centre position. The author must cite the table number both at the beginning as an introductory sentence and at the end as an explanation of the meaning of the table. It is not permitted to display more than 1 table sequentially without a separating sentence between the tables. This also applies to the use of images such as the example in Figure 1.

Figure 1 shows that the number and name are positioned at the bottom of the image. Image numbering is bolded and italicized, but the name of image is only in italics. Both the number, name and writing on the image use TNR 10 pt type, 1 space, with the centre position. The author must cite the image number both at the beginning as an introductory sentence and at the end as an explanation of the meaning of the image. It is not permitted to display more than one image in a row without a separating sentence between the images.

Mathematical equations must use a number in the order of the equation, and are positioned on the right. An equation is written using MS equation editor or mathtype app (not in image format). It is also typed with TNR 11 pt, space 1.5, justified paragraph such as following equation (1).

$$\int_0^{\infty} \exp \exp y \, dy \quad (1)$$

Provide as sufficient information about the formula and place information for each aspect parallel to the right. Not in descending order. Avoid excessive formula descriptions. The characteristic of the discussion is connecting research results with in line theories or previous research results. The

discussion is also an answer to the question of why facts such as those findings in the research. It should be remembered that the discussion does not repeat the data in the research results.

Conclusion ← 12pt, bold

Conclusion must be written in TNR-11 and space 1,5. Every single word in first paragraph must be indented inside 1 cm. Conclusions must answer the research objectives and be a generalization of findings according to the research problem. This section consists of approximately two paragraphs. The first paragraph describes the conclusion. Meanwhile, the second paragraph describes the recommendations.

The author must recommend it for future experiments/research. Both conclusions and recommendations are described in paragraph form, not in numbering form.

Acknowledgement ← 12pt, bold

Recognize those who helped in the research, especially funding supporters of your research. Include individuals who have assisted you in your study: Advisors, financial supporters, or many other supporters, i.e., Proofreaders, Typists, and Suppliers who may have given materials. The supporters in this research are suggested written in metadata; in supporting agency part.

References ← 12pt, bold

This part use TNR 11 pt, space 1, line spacing after-before 6 pt, and justified paragraph. If a reference has more than 1 line, then the second line and so on indents to the right 1 cm. The minimum number of references is 15 and 60% of them come from national and international journals. The editorial team will not process manuscripts with fewer than 15 references. Writing references and citations refers to APA style 7 version, and uses applications such as Mendeley. Provisions for writing references sourced from books, journals or proceedings as in the examples below. The following section separates examples of references sourced from proceedings, books, theses/dissertations, and journals. However, in manuscripts that want to be submitted to Range, they do not need to be separated but positioned in a single bibliography.
