- New tech reviews!
 - We are nearing the last days to approve outlines with a fall '24 effective date. If you met the fall '24 dean-approval deadline and your item is not on this agenda, watch for it on 11/8/23.
 - Even though the deadline for spring '24 DEA was 9/15, we are still receiving DEA proposals with spring '24 effective dates, as well as pleas for spring '24 dates. Sorry. That boat has flown. I mean, that plane has sailed. Please plan for the DEA DEADlines, especially as we transition to them being processed one year in advance like courses and programs. See next bullet.
 - If you are in the process of launching a course outline at this point in the semester, it should not have an effective date earlier than spring '25. New programs can also meet the spring 25 deadline, but program modifications can have fall 'effective dates only, so use fall '25. DEA are still in the fall '24 zone, but in spring the shift to spring '25 effective dates will happen quickly. Abide by the [Timelines page](#).

Discussion Items (after a break)

3:30 New IDST subject code: NAIS

- IDST is requesting a new subject code—**NAIS (Native American and Indigenous Studies)**--for a new course being put forth as part of IDST/Ethnic Studies expansion. That newly created introductory course, NAIS 38, will help meet the needs of the Native American community and help begin to address the longstanding absence of academic programs for this field at City College of San Francisco. This new subject code will be accepted by CSU Ethnic Studies reviewers and will help CCSF's development of future NAIS courses and crosslists.

3:40 The new accreditation [Standard 2: Student Success](#)

- Reviewing the Curriculum Committee's deep connection to this revised standard
 - Members discussed the Curriculum Committee's connections and responsibilities to the new standard. More directness to CC responsibilities was identified with 2.1, 2.3, 2.4, 2.6, and 2.8. Regarding 2.2, 2.5, 2.7, and 2.9, members felt they were weighted more in academic departments, student services, scheduling, and research. It feels like there is less Curriculum Committee weight in this new version of Standard 2.

 - Megan provided more explanation of CPL and shared several cases of students, their background (e.g., in the military with specific technical training), and how that schooling maps to coursework at CCSF, say in the AUTO Dept. Megan also discussed rubrics and departmental options and responsibilities, as well as helped the CC ponder what the CC could do to help normalize and strengthen CPL at CCSF. What might the CC do? Vet rubrics or design outline CPL addenda? Should something CPL-related be part of outline modifications that could help sunshine and solidify CPL?
- 4:04 Quick distinction of the gen ed groups: GE Breadth (CSU/IGETC focus), GE Squad (Curriculum Committee processes), GE Subcommittee (local focus).
- The GE Subcommittee description will need to be written and posted on our site and the ASEC's membership page.
 - This discussion will continue. A GE Subcommittee will be needed because the new Title 5 changes will trigger considerable restructuring of CCSF's GE courses, such as those in the current Area A.
- 4:05 Continuing the Title 5 Gen Ed Discussion and considering possible actions
- Weighing out "have to take" VS "should take" in order to graduate from CCSF
 - Ethical and academic arguments
 - Compliance and intentionality?
 - Following VS resisting?
 - [Newly passed changes to Title 5](#) that impact our GE structure
 - (1) English Composition, Oral Communication, and Critical Thinking (minimum of 6 semester/8 quarter units) including (A) English Composition (min of 3 units) and (B) Oral Communication and Critical Thinking (min of 3 units)
 - (2) Mathematical Concepts and Quantitative Reasoning (min of 3 units)
 - (3) Arts and Humanities (min of 3 units)
 - (4) Social and Behavioral Sciences (min of 3 units)
 - (5) Natural Sciences (min of 3 units)
 - (6) Ethnic Studies (min of 3 units)
 - The CC was again joined by several social sciences colleagues who would like to retain CCSF's US history and Government graduation area. This has always looked like a GE area at CCSF, as have local Area G and Area H, but they have all been CCSF graduation requirements.
 - CCSF's Area F (US History and Government) is a graduation requirement at CSU (American Institutions and Ideals), and CSU is still accepting lower division courses from community colleges for this. Could they shift to upper division only, as they are doing with lifelong learning (Area E)?
 - It's vital that barriers be broken for students. If CCSF were to add graduation requirements beyond the new Title 5 GE areas, would those additions be barriers or simply areas of knowledge that citizens need?
 - A number of ethical arguments were presented to continue having a local US History and Government graduation requirement in fall '25.
 - Nobody from PE&D or Health attended to present similar arguments for a wellness graduation requirement, although the idea was raised by some CC members. Would it be right to continue one current graduation requirement and not the other? (Other local graduation requirements—Composition, Math, and Ethnic Studies—will be part of the Title 5 change (see above), so there is nothing to debate there.)

- What about waivers for students in high demand majors? That is currently an option with local Area G. Could a waiver apply to US History and Government?
- Reminder–Double-dipping can happen with a graduation requirement and a GE area. Locally, CCSF could forbid double-dipping, as has been the case with the current Areas D and F. This goes back to the argument of students *must* take X versus students *should* take.
- Conversations explored the possible negative impacts on other local Area D courses if CSU-bound students were encouraged to make their Area D choice a US History and Government course. What about all of the wonderful behavioral science, gender, and sexuality courses in local Area D?
