What information do we collect?

We collect information from you when you use services provided by our application, place an order, subscribe to our newsletter or fill out a form.

What do we use your information for?

Any of the information we collect from you may be used in one of the following ways:

- To personalize your experience to provide a better service. (Your information helps us to better respond to your individual needs)

- To improve our application based on the information and feedback we receive from you

- To improve customer service as your information helps us to more effectively respond to your customer service requests and support needs

- To process transactions

We may create anonymous data records from your details by excluding information (such as your name) that make the data personally identifiable to you. App-Tech reserves the right to use anonymous data for any purpose and disclose anonymous data to third parties in its sole discretion, but generally:

- We use anonymous data for campaigns, advertising, and analysis.

- We also use anonymous information to improve our products and services.

Your information, whether public or private, will not be sold, exchanged, transferred, or given to any other company for any reason whatsoever, without your consent, other than for the express purpose of delivering the purchased product or service requested.

- To administer a contest, promotion, survey or other feature

How do we protect your information?

We implement a variety of security measures to maintain the safety of your personal information when you place an order or enter, submit, or access your personal information.

We offer the use of a secure server. All supplied sensitive information is transmitted via Secure Socket Layer (SSL) technology and only accessed by those authorized with special access rights to our systems, and are required to keep the information confidential.

After a transaction, your private information (credit cards, social security numbers, financials, etc.) will not be stored on our servers.

Do we disclose any information to outside parties?

We do not sell, trade, or otherwise transfer to outside parties your personally identifiable information. This does not include trusted third parties who assist us in operating our application, conducting our business, or servicing you, so long as those parties agree to keep this information confidential. We may also release your information when we believe release is appropriate to comply with the law, enforce our application policies, or protect ours or others rights, property, or safety. However, non-personally identifiable visitor information may be provided to other parties for marketing, advertising, or other uses.

Children's Online Privacy Protection Act Compliance

We are in compliance with the requirements of COPPA (Children's Online Privacy Protection Act), we do not collect any information from anyone under 13 years of age. Our application, products and services are all directed to people who are at least 13 years old or older.

Online Privacy Policy Only
