X. A. Crittenden SPSA

• If Chronic Absenteeism is the metric used on the CA dashboard regarding student attendance, could it be included in the SPSA in the future along with Average Daily Attendance?

We do not add these items in the site plan because of the dashboard's release date. We would need to delay approval of SPSAs until February in order to include dashboard data. Administrators are charged with making adjustments and communicating those during their evaluation meetings.

• Would this be a useful metric?

No, it would significantly delay the site plan approval process.

XI. C. Dress Code Policy

How/when can students and parents give input on a school's dress code?

Every year site councils approve SB187 as part of their larger safety plan.

 Is there a way for students to give anonymous input (for fear of retribution or feelings of body-shaming) on the school dress code?

There is always the opportunity to provide anonymous feedback. There are no "formal" ways to give anonymous feedback.

Is this included in the school climate survey?

No

When will the school climate survey be administered?

As part of the board approved budget cuts, we removed the climate survey, and have now included it with LCAP survey that will be administered in February.

 Do we have a system in place to record dress code violations (not just suspensions), including the student demographics and discipline responses?

Yes, we use power school.

o Is this included in systems we may already have in place to record discipline incidents at schools?

See above.

How many dress code violations have occurred at each school, particularly the middle schools?

There has only been one incident in the last 6 years; at Graham Middle School.

 Who is dress-coded: are there disparities in gender, race/ethnicity, or other student groups that are disproportionately dress-coded?

There is no data to suggest that any group of students are being targeted.

What are the dress code violations most commonly for?

There is no data about what items of dress are most commonly found in violation.

 Were students removed from class or instructional time due to dress code violations, i.e. waiting in the office for a parent to bring a change of clothes?

There is no data to suggest that students are missing class time. The goal always is to rectify issues as quickly as possible.

Who determines if a student has violated the dress code?

All staff are expected to address dress code violations.

What constitutes a "distraction" from learning?

This would be a situational question.

Is observation of students' bodies being used to determine a dress code violation, e.g. are students asked to
measure the length of their shorts to their fingertips or mid-thigh while being observed by a school
employee?

We have not had a dress code violation since 2014.

How are staff trained on the dress code at our school sites?

Staff are trained on how to address discipline at the start of the school year. If principals decide that a team needs a refresher, then they use faculty meetings.
