“The latest poll, conducted by Redfield & Wilton Strategies on behalf of *Newsweek* on April 6 and 7, suggests most people think squatters are no more than

trespassers. Some 4,000 people were questioned for the survey, and respondents were all eligible voters in the U.S. who had a range of ages, genders, ethnicities, and education levels. A total of 71 percent said they supported New York's bill, with 49 percent strongly supporting the move to treat squatters as trespassers and 22 percent merely supporting it. In contrast, just 8 percent disagreed with the bill, with 5 percent opposing it and 3 percent strongly opposing it. The rest of the respondents neither opposed nor supported it (15 percent) or did not know how they felt about the matter (6 percent). The poll also asked other questions surrounding the topic of squatter occupations. Some 61 percent said they opposed the idea of 'squatters' rights' in general, with just 18 percent of respondents supporting the concept. The remaining respondents neither supported nor opposed the concept (15 percent) or did not know what they thought about the issue (5 percent). The figures in the poll were rounded to the nearest full number so do not always add up to exactly 100 percent. While 66 percent of people who believe the current law in New York is too lenient believe squatters should 'never' be given rights, no matter how long they have inhabited a property."

5. Humanitarian parole. Temporary stay allowed due to a compelling emergency.
6. In the country through the One app, which was essentially a legal fast-track to

entry.

7. Awaiting asylum case decision.

According to them: “Ninety percent of the time people with uncertain statuses fall into these first two categories, according to immigration experts — either with expired visas, or crossing the border without inspection.”

The border hoppers and visa violators were given the option to self-deport. They were also offered money, and a free ride. Stop and think about that. Strong employment in the U.S. construction sector—a leading employer of Mexican migrants—best explains the recent growth of remittances to Mexico. Mexico is the second-highest receiver of remittances in the world, trailing only India. The payments, mostly from migrants in the U.S., provide a valuable lifeline for millions of Mexican households. They are used mainly for necessities—food, clothing and health care—while they also make up an important part of household expenditures for housing, tuition and debt repayment. Remittances from the U.S. to Mexico reached a record \$55.9 billion in 2022. These transfers accounted for 95 percent of Mexico’s total remittances of \$58.5 billion. Mexican migrants, who number 11 million in the U.S., typically send the funds home to support their families. The average monthly remittance to Mexico was \$390 in 2022. In economics terms, the impact of remittances is broadly split based on whether the payments are for consumption or investment purposes. Investment objectives, including human capital, can have positive long-run effects on recipient households and communities by improving health outcomes and increasing educational attainment, earnings and wealth. There is [evidence](#) that at the local level in Mexico, households use remittances not only toward consumption but also toward

productive activities favoring economic growth.”
