

CANI FATHER'S DAY – TERMS & CONDITIONS

1.3 The Promoter reserves the right to appoint an authorised agency or partner to administer portions of the Cani Father’s Day promotion on its behalf.

2. CANI FATHER'S DAY PERIOD

2.1 The Cani Father’s day competition will run from period of 05 June 2026 until 21 June 2026 by the Promoter across its digital and social media platforms.

3. ELIGIBILITY

3.1 Participation is open to legal residents of South Africa aged 18 years or older.

9.1 To the fullest extent permitted by law, the Promoter shall not be liable for:

- Lost, delayed, incomplete, corrupted, or inaccessible submissions
- Any loss, injury, damage, or claim arising from participation in the Cani Father's Day competition
- Any interruption, cancellation, or amendment of the Cani Father's Day competition

10.4 These Terms shall be governed by the laws of South Africa.

10.5 Any disputes arising from the Cani Father's Day competition shall be subject to the exclusive jurisdiction of the courts of South Africa.
