



## **ROADS Advisory Panel**

Teleconference

20th August 2024, 14-1530 UTC, 16-17 CET, 10-11 EDT

### **1. Welcome and Review of Agenda**

The SAON ROADS Co-chair, Lauren Divine, welcomed participants to today's teleconference (List of participants Appendix 1) and referenced that today's agenda (Appendix 2) would be focusing on the evaluation of the Sea Ice Expert Panel (EP) Phase I documentation.

### **2. Breakout Groups for the Review of the Sea Ice Documentation**

The SAON ROADS Co-chair, Sandy Starkweather, introduced Talia Wells (Arctic Institute of North America) as the champion of the Sea Ice EP. Sandy noted that the Phase I Evaluation form is unchanged from previous evaluations, and that breakout groups would be formed amongst today's participants to review the sea ice documentation. Talia outlined that the EP is meeting regularly and that they hope to have preliminary Phase II material ready for the Arctic Circle Assembly in October, together with an in-person meeting of the Expert Panel. Sandy asked for ideas from Advisory Panel (AP) members on societal benefit frameworks that could be used in evaluation of sea ice efforts.

Sandy commended the Sea Ice EP for the well-thought-out Phase I documentation. It was evident that the EP was aware of the evaluation rubric and it showed in their documentation. Sandy encouraged the AP members to complete their evaluations as soon as possible. It was agreed that Jan Rene Larsen would compile all the evaluation comments into one summary document to provide feedback to the Sea Ice EP. Comments were requested from AP members by September 3<sup>rd</sup>.

### **3. Upcoming Events**

Jan Rene highlighted a series of upcoming events as follows:

- a. **RNA CoObs Meeting** 27-30 August in Fairbanks, AK. An Open Partnership meeting is scheduled in association with this meeting on August 28<sup>th</sup>. Remote participation is possible and encouraged by AP members. Margaret Rudolf stated that given the large number of anticipated Indigenous participants, that the Open Partnership meeting will focus on Indigenous engagement in the ROADS process. Discussions will take place on what could be in a "Phase 0" document as a guidelines style of document or starter kit to the ROADS process. Sandy noted that discussions are also starting on a possible survey about the ROADS process, and that input is welcomed on this as well.
- b. **2024 European Polar Science Week** / 3-6 September 2024 / <https://www.polar-science-week.eu/>. There will be sessions on ROADS. It was noted that no remote participation will be possible.

She noted that they hope to engage discussions on what the next generation of candidate EPs might look like and seek opportunities to complement ROADS with other kinds of planning mechanisms.
