**#06-21      RECOMMENDATIONS**

Picchetti moved and Roth seconded the motion for the approval of the following resolutions by the Indian Valley Board of Education, as recommended by the Local Superintendent, and listed as follows:

- Signatories for 2021  
Designation of the Treasurer, or Treasurer Pro Tempore, as Signatory for All Accounts for 2021.
- Authorize Request for Tax Advance  
Authorization for the Treasurer or Treasurer Pro Tempore, to request advance on the first and second half collections of real estate property taxes.
- Set Board of Education Budget - 2021  
Establishment of a Service Fund, not to exceed \$5,000, to pay expenses incurred by Board of Education Members in the execution of their duties.
- Authority to Pay Bills  
Authorization of the Treasurer, or Treasurer Pro Tempore, to pay utilities, insurance premiums, petty cash, and other bills that are due prior to the next Board Meeting. Such bills are to be listed on the next Board Meeting listing of bills.
- Active and Interim Funds  
Authorization of the Treasurer, or Treasurer Pro Tempore, to invest all available active and interim funds at the most productive rate available.
- Federal Programs  
Appointment of the Superintendent to be responsible for all federal programs and grants, and that the Superintendent be further authorized to appoint designees to represent the District. This resolution shall include Title IX and 504 Programs.
- Civil Rights Compliance  
Authorization of the Local Superintendent as the official designee to oversee that the Indian Valley Local School District is in Civil Rights Compliance.
- Philosophy of Education  
Affirm the Philosophy of Education (District Policy 2110)
- Statement of Ethics  
Affirm the ethical expectations for administrative, professional, and classified staff (District Policies 1200, 3210, & 4210).
- Records Commission  
Appointment of the Superintendent, Treasurer, and President of the Board of Education as the School District Records Commission for 2021.
- Appointment of Personnel  
Authorize Superintendent to employ personnel pending approval by the Board of Education at the next regular meeting of the Indian Valley Board of Education.
- Acceptance of Resignations  
Authorize Superintendent to accept resignations which have been submitted by employees pending approval by the Board of Education at the next regular meeting of the Indian Valley Board of Education; provided however, upon approval by this Board, such resignations shall be deemed effective as of the date and time of the Superintendent's acceptance.
