Eerie Emporium 2025 Vendor Rules & Guidelines

- 1. Set-up is from 10am-11:45am. Vendors need to be set up and ready to sell by 11:45am. No vendors will be allowed to begin setting up after 11:30am. Vehicles must be unloaded and immediately moved from the market area.
- 2. Tear-down is from 5-6pm. Vendors must remain open until 5pm; no early tear-downs are permitted.
- 3. You will be directed to your assigned space Upon arrival. Check in with Bella or Minda..
- 4. Vendors agree to abide by all applicable local and/or state rules and regulations regarding production of goods for sale, packaging, tax collection, etc. Vendors are responsible for their own monetary transactions (including taxes).
- 5. If using a tent, it should be no larger than 10'x10'. Tents, canopies and umbrellas must be anchored/weighted down securely at every pole.
- 6. Vendors will provide all equipment, supplies, lighting, and other materials necessary for selling their products, including having bags and providing change.
- 7. The Eerie Emporium will be held rain or shine, but please use your own judgment in cases of questionable weather.
- 8. Vendors will hold harmless the Eerie Emporium/QC Haunts & History and the owners and operators, as well as the City of Rock Island and employees. Vendors are solely responsible for their own insurance. The Eerie Emporium/QC Haunts & History, Minda Powers-Douglas, or the City of Rock Island will not be held accountable for any damages incurred at the event, including but not limited to: loss of revenue, damage to goods or any items, and physical injury.
- 9. No weapons, drugs, or drug paraphernalia will be allowed on the market grounds. Anyone violating this rule will be immediately and permanently escorted off the premises.
- 10. The registration fee is non-refundable for any reason, including, but not limited to, cases of inclement weather or state mandated closings.
- 11. Each vendor must independently apply to the market. Booth sharing isn't permitted without prior approval from market management.
- 12. By participating in the Eerie Emporium you agree to allow QC Haunts & History and the Eerie Emporium to post pictures of you or your products, and/or to use such photos for marketing.
