Superintendent Report:

Busing – partnering with First Student. Positions for drivers are still open.

Act 73

Letter to the task force – Chris did send the Cabot letter to the task force.

Legislature will be selecting one of the three maps that will be presented.

At the SU level other districts shared what their preferences were for redistricting.

Discussion on the classroom minimum size issue that Cabot might face.

Jennifer shared where Cabot's figures are at this time.

Alicia noted that she would like to have Cabot be open to some sort of transition plan. Consider not turning down any students that would like to be part of the lottery. Matt is not sure Cabot can just open the numbers to the lottery; the State has guidelines that need to be followed. Need to be methodical.

Chris asked Matt to see if Mike Concessi's previous figures for tuitioning out high school students can be reshared.

Discussion on Cabot putting out a survey to see if Cabot does not have a high school, which school would they like for their student to attend.

Verify if the tuition cap would apply to private schools as well within the new law.

A question to the community - would they prefer to stay within a supervisory union that has high school options or Cabot becoming a school choice school? Factors such as busing etc., need to be looked at.
