# Terms and Conditions Carnaval Sztukmistrzów Festival held on July 24–27, 2025, from 11:00 AM to 3:00 AM

### **General Provisions**

- 1. The following terms and conditions (hereinafter referred to as TaC or Terms and Conditions) have been prepared by the organisers of Carnaval Sztukmistrzów 2025, which will take place from July 24 to 27, 2025, between 11:00 AM and 3:00 AM (hereinafter referred to as the "Event").
- 2. Carnaval Sztukmistrzów is organised by Warsztaty Kultury w Lublinie (Workshops of Culture in Lublin) with its registered office at Grodzka 5a in Lublin (hereinafter referred to as "The Organiser").
- 3. The events of Carnaval Sztukmistrzów 2025 will take place in Lublin's city centre, particularly the following locations: Old Town, Błonia near the Castle, Litewski Square, Łokietka Square, the pedestrian zone, Grodzka 5a and 7 buildings, the Old Theatre, the Centre for Culture in Lublin and others (hereinafter referred to as the "Venue"). Detailed event locations can be found in the evemt's programme, available at carnavallublin.eu.
- 4. The provisions of this TaC do not infringe on the rights and obligations of third parties if their activities are located and conducted in the Venue prior to the start of the event. The Organiser bears no responsibility for any incidents or events occurring in areas occupied by such third parties.
- 5. The Terms and Conditions apply to all individuals present in the Venue during the Event (hereinafter referred to as "Participants"). All persons present in the Venue during the Event are required to comply with the provisions of these Terms and Conditions. Minors take part in the Even at the sole responsibility of their legal guardians.
- 6. The purpose of these Terms and Conditions is to ensure the safety of the Event by defining the rules of conduct for individuals present at the Event and their use of the Venue and its equipment.

## Participation in the Event

- 1. Admission to the event is free, except for specific paid events listed in the Event programme, available at www.carnavallublin.eu.
- 2. Entry to closed performances is only possible upon presenting a ticket/voucher purchased at authorised sales points indicated on the website <u>carnavallublin.eu</u>.
- 3. Attendance at paid events requires purchasing an entrance ticket at a price listed at <a href="https://www.carnavalublin.eu">www.carnavalublin.eu</a>. If sold through an external operator, the terms of sale are defined by that operator's separate regulations.
- 4. Audience members are asked to arrive at least 15 minutes before the start of ticketed shows to take their seats. They are also encouraged to read the show descriptions and comply with any age restrictions. Latecomers will not be admitted until an intermission (if one is scheduled). Tickets become void once the show begins and are non-refundable.

- 5. Taking pictures and filming is strictly prohibited during ticketed performances, and all mobile phones must be turned off.
- 6. Seating at open-air events is not assigned. Seating for ticketed shows is also unassigned unless the show takes place at the Old Theatre, where attendees must occupy the seats indicated on their tickets.
- 7. The Organizer records the Event in photographs and videos for documentation and promotion of future events. The image of persons present in the Venue may therefore be recorded and later used for documentation, reporting, and promotional purposes. By attending the Event, Participants agree not to claim compensation from the Organiser for the use of their image in press, TV, or online coverage.
- 8. All participants are required to conduct themselves in a manner that does not endanger the safety of others and must comply with occupational health and safety regulations, fire safety regulations, current epidemiological guidelines, and the provisions outlined in these Terms and Conditions.
- 9. Participants must follow the instructions of the Organiser and the event security staff.
- 10. Bringing the following items into the Venue is strictly prohibited: alcoholic beverages, intoxicants and psychotropic substances, weapons, dangerous objects, explosives, and pyrotechnics.
- 11. The Organiser has the right to remove from the Event anyone attempting to bring in or possessing the prohibited items listed above, as well as individuals whose behavior threatens the safety of others, disrupts order, or violates generally accepted standards of public conduct. The Organiser may also remove anyone who disturbs other Participants or acts in an offensive manner.
- 12. Conducting any commercial, profit-making, promotional, advertising, or political activities within the Festival Area without the Organiser's consent is prohibited. This provision does not apply to areas occupied by third parties located within the Venue.
- 13. The Organiser informs that Participants may be exposed to high sound levels that may lead to hearing damage. The Organiser is not liable for any such damage or resulting health issues.
- 14. In the event of fire or other danger to life, health, or property, Participants should:
- immediately notify event security staff;
- avoid panic;
- follow the instructions of security or information staff;
- Leave the Venue calmly

### **Event Safety**

- 1. The Organiser is committed to providing a safe and secure environment for all Event Participants. Security personnel and medical professionals will be present on-site throughout the duration of the event.
- 2. The security services are authorised to:
  - a) Supervise safe entry and exit of Participants;
  - b) Prevent access to restricted areas;
  - c) Deny entry to individuals visibly under the influence of alcohol, drugs, or similar substances;
  - d) Deny entry to individuals carrying weapons or other prohibited items listed in these Regulations;
  - e) Issue instructions to individuals disturbing public order or violating the TaC, and, if such instructions are ignored, request them to leave the Event;
  - f) detain, and promptly hand over to the police, individuals who pose a direct threat to persons or property or who commit unlawful acts;
  - g) provide information about the location of information points and medical stations in the Venue

#### **Final Provisions**

- 1. The Organiser reserves the right to determine and modify the schedule and programme of the Event in terms of timing and artistic content without providing a reason.
- 2. The Organiser is not liable for consequences caused by force majeure. Force majeure refers to events beyond the Organiser's control that make fulfilling obligations impossible or unfeasible. This includes, in particular, weather conditions, equipment failures, or disruptions in the power supply.
- 3. The Organiser is not responsible for any personal items left in the Venue
- 4. These Terms and Conditions are available at the Organiser's office, at the information point, other locations within the Venue, and on the website <a href="www.carnavallublin.eu">www.carnavallublin.eu</a>.
- 5. These Terms and Conditions are valid from July 24 to 27, 2025.

- 6. Participation in the Event constitutes acceptance of these Terms and Conditions by the Participant.
- 7. All disputes and matters not covered in these Terms and Conditions as well as the interpretation of their provisions, are subject solely to the Organizer's discretion.
