## Court expansion/lighting

- LW confident about completion of the courts January 26th, 2024. 5 days for shipping and 5 days for installation of the sound mitigation material.
- Reviewing all the existing courts for repair 5, 6, 8. To be done after the completion of the new courts.
- Meeting tomorrow with general acrylics tomorrow
- General acrylics have redone the electrical and plumbing so it's all recessed.
  Issues with the sound material will be on the East side of the new courts, not of courts 6 & 8. Accousta fence on the homeowners wall, no gates to be installed.
- Awaiting to see how many funds are left over from the project to put towards LED lighting. better lighting to play with, change degrading poles and improve ambient lighting for the surrounding residents.
- LW being fiscally responsible new mandate to be in partnership with clubs for improvements. Spoke with Clark and Justin from LW they are in favour.
- Upgrade for the pb kitchen floors and air conditioning in the present budget as well as an ice maker.
- Sound study 'at the ready' once the sound mitigation material is installed the study will occur.
- Will require 64 people same company that previously did the study will do the post material study
- New material is sound absorbing as opposed to acousta fencing.
- Will do a walk through with general acrylics of all the courts for repair. Repairs will be complete prior to the tournament.
