- Prescribe, monitor, and manage medications while evaluating therapeutic effectiveness and potential adverse effects.
- Perform routine medication management follow-up appointments and adjust treatment plans as clinically indicated.
- Conduct suicide risk, violence risk, and safety assessments and implement appropriate interventions when necessary.
- Provide brief supportive psychotherapy, education, and behavioral interventions to enhance treatment outcomes.
- Individualize treatment management with lab orders, DNA testing and referrals for complimentary therapeutic interventions.
- Coordinate care with primary care providers, therapists, specialists, hospitals, schools to ensure continuity of care.
- Maintain timely, accurate, and legally compliant documentation.
- Complete clinical documentation including prior authorizations, disability forms, FMLA paperwork, medication refill requests, and other treatment-related documentation as needed.
- Adhere to all HIPAA, DEA, Arizona Board of Nursing, and applicable federal and state regulatory requirements.
- Provide both in-person and telehealth services as appropriate.
