# Criminal Offences

## Being in a relationship with a minor

Based on available evidence, Anthony is currently in a relationship with a 16-year-old individual ("Vikk"). In California, the age of consent is 18 years old. As such, any sexual or exploitative interaction involving a minor under 18 constitutes a criminal offense.

The following concerns are supported by collected evidence (screenshots and communications in my possession):


- Anthony has openly acknowledged being in a relationship with a minor (Vikk, age 15-16). If Anthony acted responsibly he would not have been in a relationship with a minor.
- There are documented statements in which Anthony admits to grooming behavior.
- Evidence suggests Anthony expresses attraction toward minors.
- The minor involved is believed to be particularly vulnerable, having reportedly been groomed previously.

These actions may fall under California criminal statutes, including but not limited to:

- **Penal Code 288.3 – Contact with a Minor with Intent to Commit a Sexual Offense:** Prohibits contacting a minor with intent to seduce, arouse, or commit sexual acts, even without physical meeting.
- **Penal Code 288.2 – Sending Harmful Matter to a Minor:** Prohibits sending sexually explicit content to a minor with intent of sexual arousal or exploitation.

All claims made in this report are supported by documented evidence, which I am prepared to provide upon request. This includes screenshots of conversations and admissions made by Anthony. Everything will be stated in this document.

Given the seriousness of these concerns and the potential risk to the minor involved, I respectfully request that this matter be reviewed and investigated.

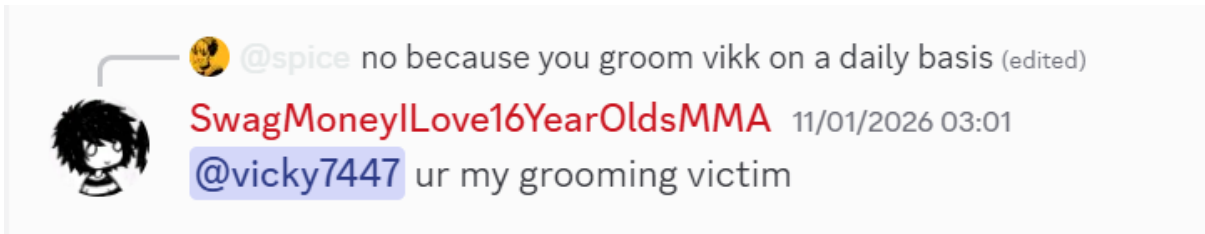


## Proof of grooming and admitting to it

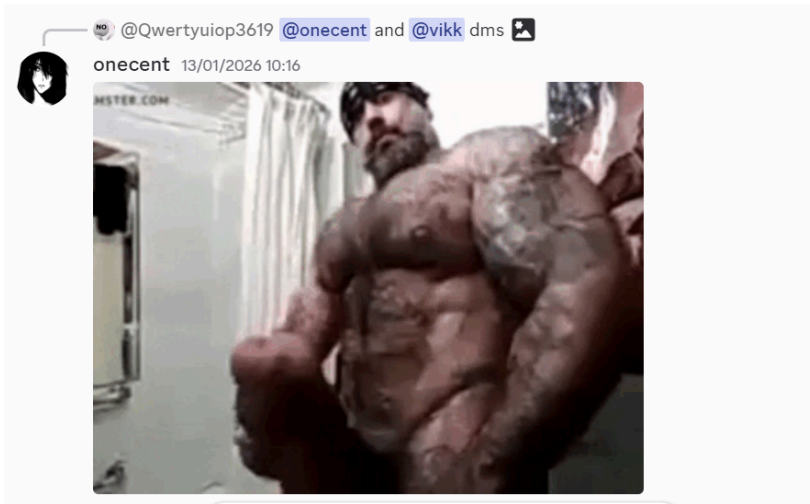

He also once changed his nickname in the same Discord server as "SwagMoneyIlove16YearOldMMA" as well. Indicating that he identifies with being a groomer.

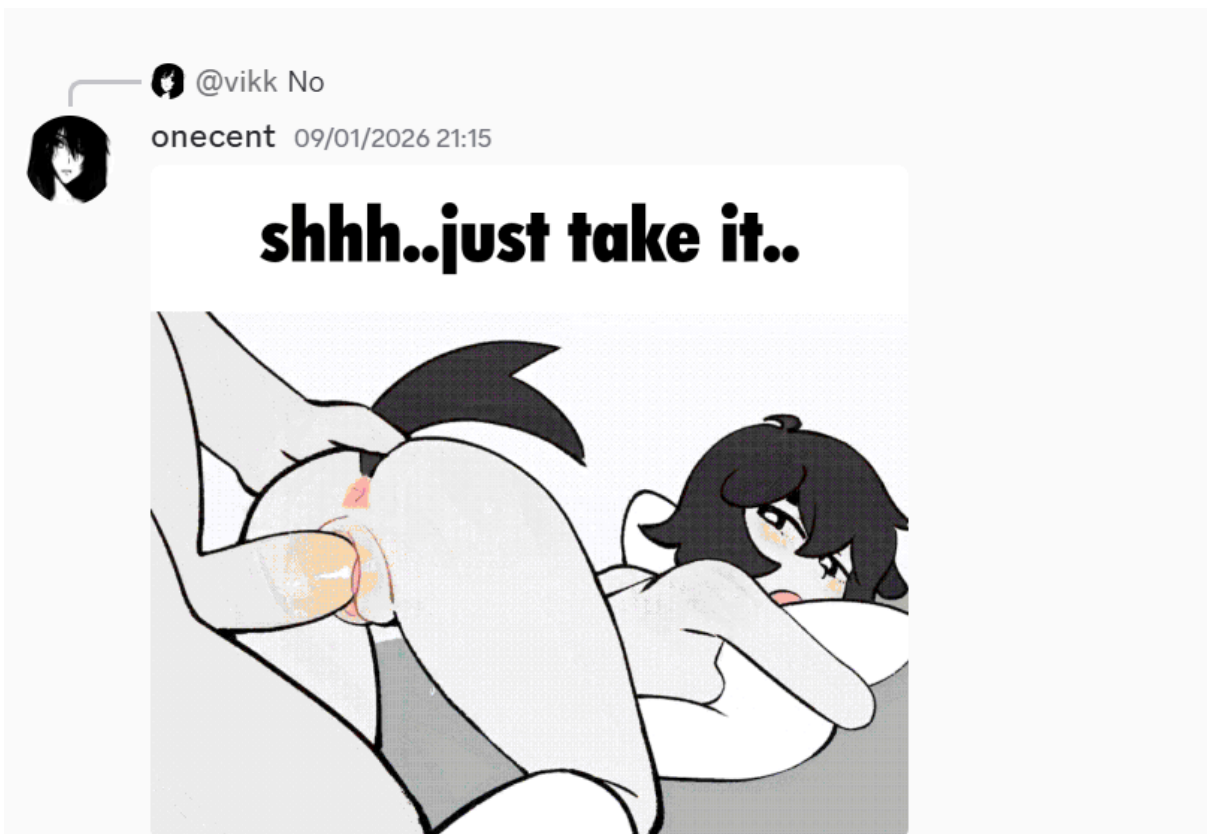

### **Intentionally exposing pornography to minors**

There is documented evidence showing that Anthony shared pornographic or sexually explicit material in Discord servers that included minors, without restricting the content to NSFW-designated channels or using content warnings. Distributing explicit sexual material in spaces accessible to minors raises serious safety concerns and may violate both federal and California law. Under federal law, 18 U.S.C. § 1470 prohibits knowingly transferring obscene or sexually explicit material to individuals under the age of 16 using the internet or electronic communication. Depending on the nature of the material and the ages involved, additional federal statutes concerning harmful material distributed to minors may also apply. California law similarly prohibits the distribution of harmful matter to minors under Penal Code § 288.2, including electronic transmission of sexually explicit content with sexual intent or reckless disregard for minor exposure. The fact that the material was allegedly posted in



channels accessible to minors, without age restriction or warning mechanisms, demonstrates potentially reckless conduct that warrants investigation. Screenshots and archived message evidence supporting these claims are available for review.

## Assaulting woman

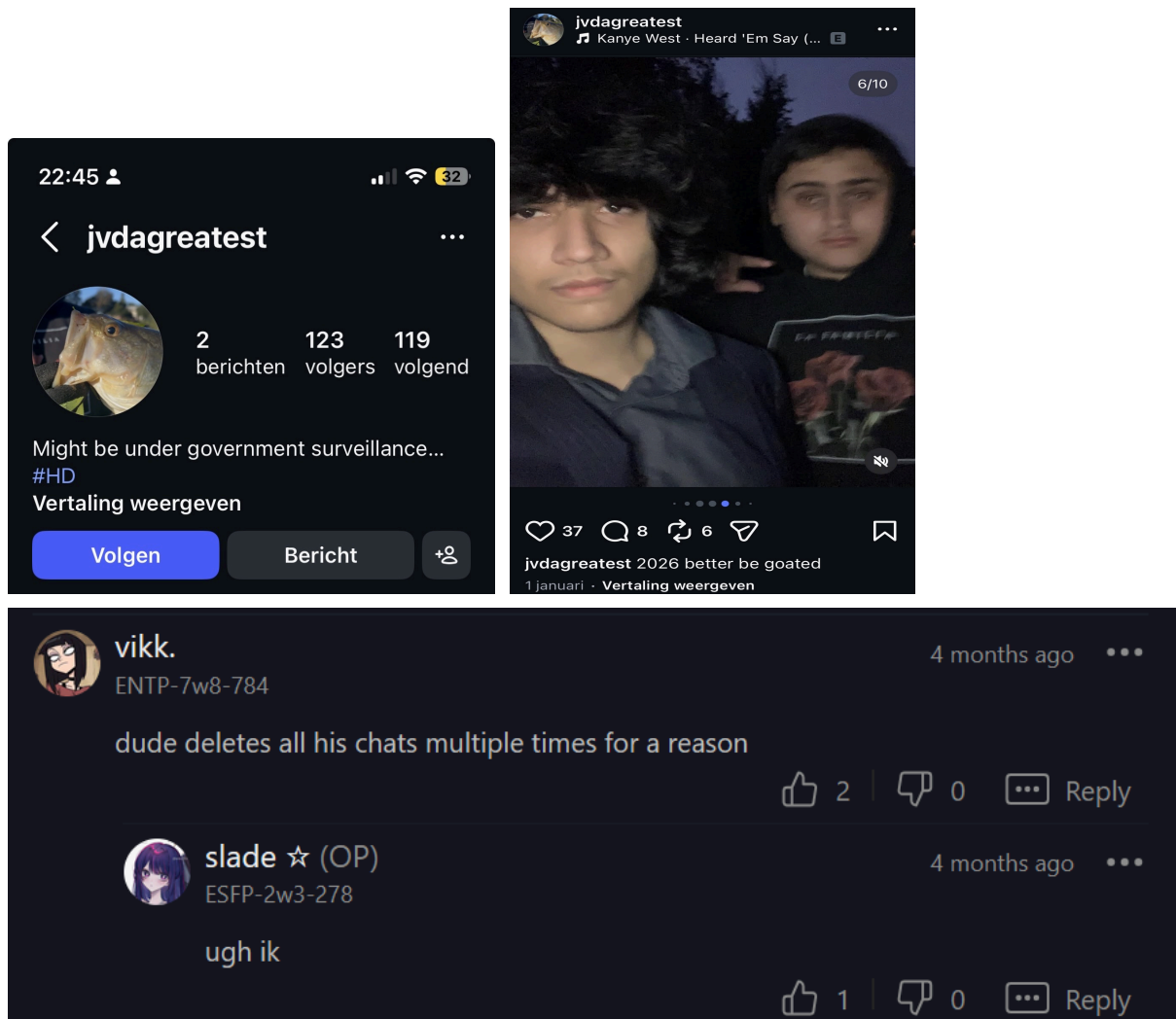
In addition to the concerns outlined above, there are documented statements in which Anthony admits to engaging in physically abusive behavior toward women. Such conduct, if substantiated, may constitute violations of California law, including domestic violence and assault statutes. Under California Penal Code § 273.5, it is a criminal offense to willfully inflict corporal injury resulting in a traumatic condition upon a spouse, cohabitant, or intimate partner. Similarly, Penal Code § 243(e)(1) addresses battery against an intimate partner, and Penal Code § 240–242 defines assault and battery more broadly. These offenses may be prosecuted regardless of whether the victim initially reports the incident, particularly where admissions or other corroborating evidence exist. Statements indicating repeated acts of violence toward multiple individuals suggest a potential pattern of abusive behavior, which raises significant concern for the safety of others and warrants further investigation by law enforcement.



## Potential attempt to remove evidence after becoming aware of a report

Following the submission of a report by me to federal authorities, Anthony's Instagram account was deleted. The timing of this action, occurring after the report was filed, may be consistent with an attempt to remove or conceal potential evidence. Additionally, a known associate of Anthony referenced possible government surveillance in a public profile, suggesting awareness of investigative attention. Under U.S. law, including 18 U.S.C. § 1519 (destruction, alteration, or falsification of records in a federal investigation) and 18 U.S.C. § 1512 (tampering with evidence or attempting to obstruct an investigation), it is a criminal offense to knowingly destroy or conceal evidence with the intent to impede or influence an investigation. California law similarly prohibits the destruction or concealment of evidence

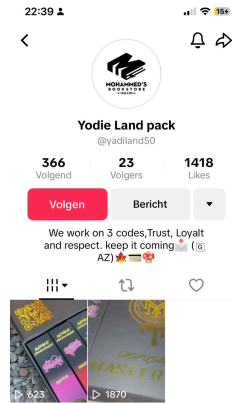
under Penal Code § 135. While further investigation is required to determine intent, the sequence of events raises concern that relevant digital evidence may have been intentionally removed and warrants review by law enforcement.



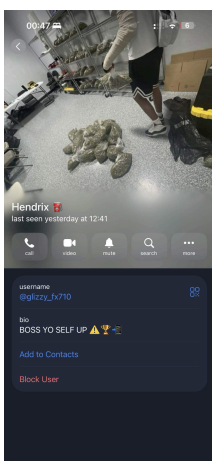
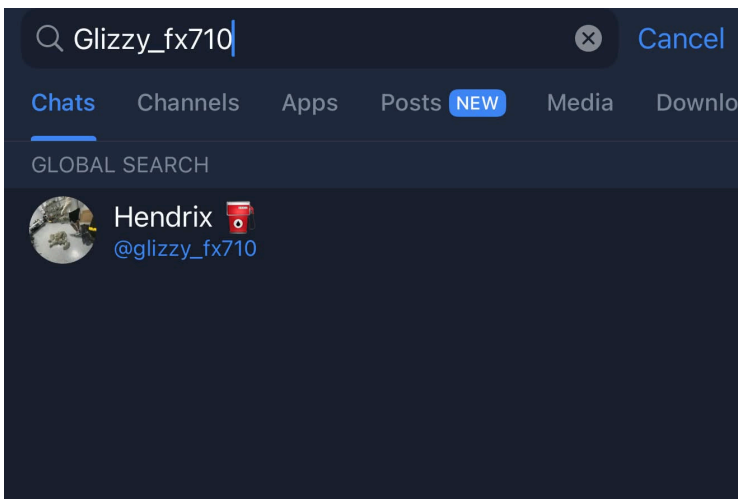

### Illegal usage of drugs

There are also online statements and activity attributed to Anthony indicating potential involvement with illegal substances, including references to personal drug use and apparent association with accounts that promote or distribute controlled substances on platforms such as TikTok and Telegram. Under U.S. law, the Controlled Substances Act (21 U.S.C. §§ 841–844) prohibits the possession, distribution, or use of controlled substances without authorization. California law similarly addresses these offenses under the Health and Safety Code, including § 11350 (possession of certain controlled substances) and § 11352 (transportation, sale, or distribution). It should be noted that merely following or interacting with social media accounts does not, by itself, establish criminal activity; however, statements or evidence indicating possession, use, or intent to obtain or distribute controlled substances may warrant further review. Evidence will be stated here below.



As of April 2026, cannabis is generally **illegal for recreational use and purchase** in California for individuals who are 19 years old, as the state requires consumers to be at least **21 years old**. [Department of Cannabis Control \(.gov\) +1](#)



## Doxxing

Evidence indicates that Anthony publicly disclosed the residential address of Maxwell Peterson during an ongoing personal conflict between the two individuals. Screenshots preserved from Anthony's own Discord server show discussions and exchanges demonstrating a hostile dispute between Anthony

and Maxwell Peterson prior to the publication of the address. Additionally, online content attributed to Anthony allegedly contains Maxwell Peterson's full residential address, making the information accessible to others without the victim's consent. Given the context of the dispute, the disclosure appears consistent with an attempt to harass, intimidate, or encourage unwanted contact directed at the victim. Such conduct may implicate California Penal Code § 653.2, which prohibits the electronic distribution of another person's identifying information for the purpose of causing harassment, threats, or unwanted contact. Depending on the circumstances and resulting conduct, the publication of personal information may also support related harassment or stalking investigations. The preserved screenshots, online content, and associated communications provide context regarding motive and intent and are available for review by investigators.
