> College Writing R4B: Reading Composition and Research "Golden Myths: California Then and Now"

### Course description:

This course serves as an introduction to research and research based writing by inviting students to look back through California's eclectic histories and make connections to some of the contemporary issues they have spawned. In doing so, the primary objective will be to examine how writers and researchers have made sense of California's history and current events, and begin to apply some of these techniques through acts of research and writing. This course is predicated on the idea that our job as scholars is to explore, understand, and form opinions on difficult problems, and that California's diverse social, cultural, environmental, economic, and regional landscapes stand to benefit from intellectually informed ideas moving into the future. Beginning with an overview of established theory related to the study of California as both a place and a concept, we will work together to define limited fields of study. Students will then identify and pursue issues relevant to their interests within these fields. Students will be asked to read deeply and carefully, with the goal of forming defined perspectives on a specific topic of their choice through in-depth research and writing.

# Reading, Composition and Research:

R4B "offers students structured, sustained, and highly articulated practice in the recursive processes entailed in reading and composing, as well as critical analysis. The seminar affords students guided practice through the stages involved in creating a research paper." In response to class readings and original research, "students craft several short pieces leading up to two longer essays—works of exposition and/or argumentation. Students also draft a research paper, developing a research question, gathering, evaluating, and synthesizing information from texts and other sources. Elements of the research process, such as proposals, annotated bibliographies, abstracts, "works cited" lists, and the like, are submitted, along with the final report, in a research portfolio. Students write a minimum of 32 pages of expository prose during the semester."

This course satisfies the second half (Part B) of the Reading & Composition Requirement.

# **Course Requirements:**

- 1. Students will be responsible for coming to class ready to discuss all readings assigned to them for that meeting. This means bring all books and materials necessary for the day's class. You will be expected to engage in informed discussions pertaining to a text's content, its formal features, its cultural context, or other relevant aspects as deemed necessary.
- 2. Class time will regularly be devoted to discussion of daily readings and assignments, as well as topics related to writing and research. Students will frequently be asked to work together in revision groups and/or research groups, which will meet during class, and in some cases before, after, or between classes.
- **3.** During the semester you will be expected to keep a **writing notebook** and complete several informal and/or exploratory writing assignments in and out of class.
- 4. You are required to check your email twice daily for messages related to this course.
- 5. During the second half of the semester, students will be asked to create a portfolio of different materials and assignments related to the final research project and submit it for evaluation.
  STUDENTS ARE RESPONSIBLE TO KEEP COPIES OF ALL FORMAL AND INFORMAL MATERIAL CREATED DURING THE SEMESTER.

#### Paper Submissions:

In general, the graded papers due for this class will go through a multi-step process, with my input and the input from other students given at certain steps along the way. When you submit drafts to me, you will do so using your "bDrive," a Google platform for creating and exchanging documents that corresponds to the @berkeley.edu email address you were assigned when you were admitted to the university. At the beginning of the semester you will receive a bDrive folder from me, which will be the repository for all of your draft writing this semester. When the course begins we will review how to upload your essays to bDrive, and how to use it as an interactive tool to work with me to improve your writing.

When you are finished with the feedback and editing stages and ready to submit a final paper for evaluation, you will do so through our "bCourses" page. Your papers should include a heading with one line for your name, one line for the date, and one line with the course time and title (ie. R1A M/W/F 12-2). Papers should be typed using Times New Roman 12pt. font or Arial 11 font with margins set to 1 inch.

# Late and incomplete assignments:

All work is expected to be handed in **ON TIME** unless an extension is arranged in advance with me. For work submitted on bDrive I will make a copy of the essay at the time specified in the prompt so that you will no longer be able to make changes to your submission. This means that I will not receive a late submission unless we have already discussed a submission plan

together. Keep in mind that without an approved late submission any incomplete assignments will be marked down accordingly, having a negative impact on your final grade and your ability to successfully complete the end of semester portfolio assignment.

# A Note on Course Participation and Attendance:

Attendance is critical to successful completion of this course, and factors into your course participation grade. This doesn't mean that just showing up is all you need to do to receive your participation points. In this class, you do not get credit for simply attending class, but absences count against you. Your first absence will be excused, your second absence marked against your participation, and your third will result in a lowering of your grade. More than three absences will be considered grounds for failing the course.

That said, participation does have the potential to lift your grade, and plays a large factor in your end of the term assessment. Course participation does not just mean talking in class. It can mean meeting with me during office hours, corresponding by email, being engaged by taking notes and or asking questions, or demonstrating interest through pursuit of information. Regardless of your reason for missing class, you will want to keep up with your work. Punctuality is also important. Chronically arriving to class late or leaving early is disruptive to your classmates and will damage your final grade.
