

## AUTHORIZATION, RELEASE AND WAIVER

The undersigned, being the parent(s)/guardian(s) ("Releasor(s)") of \_\_\_\_\_ ("Student"), who is enrolled at Brussels Community Unit School District #42 ("District"), hereby agree(s) to the following.

Releasor(s) acknowledge(s) that during the 2025-2026 school term, Student will be participating in certain voluntary extracurricular activities, specifically, a golf club, and the District will NOT be providing transportation to and from these golf club activities.

Releasor(s) hereby authorize(s) and consent(s) to Student driving and/or being a passenger in a vehicle operated by another student or adult to and from golf club activities. Releasor(s) assume(s) any and all risks for physical injury, death, and/or property damage resulting to said Student that may occur while Student drives to and from golf club activities or is a passenger in a vehicle being driven by another student or adult to and from golf club activities.

As consideration for the District agreeing to allow Student to drive to and from golf club activities or to be a passenger in a vehicle being driven by another student or adult to and from golf club activities, Releasor(s) agree(s) not to make a claim against, sue, attach the property of, or prosecute the Board of Education of Brussels Community Unit School District #42, its Board members, officers, administrators, employees, and agents for personal injury, death, or property damage resulting to said Student while driving to and from golf club activities or while a passenger in a vehicle being driven by another student or adult to and from golf club activities.

Releasor(s) hereby release(s) and discharge(s) the Board of Education of Brussels Community Unit School District #42, its Board members, officers, administrators, employees, and agents from all actions and claims or demands Releasor(s), their heirs, executors, administrators, personal representatives, successors, and assigns now or may hereafter have for personal injury, death, or property damage resulting to said Student while driving to and from golf club activities or while a passenger in a vehicle being driven by another student or adult to and from golf club activities. As further consideration, Releasor(s) agree to maintain automobile liability insurance coverage in not less than the amount required by law on the vehicle driven by my/our Student. As additional consideration, Releasor(s) agree to indemnify, defend and hold harmless the Board of Education of Brussels Community Unit School District #42, its Board members, officers, administrators, employees, and agents harmless against all loss, damage, injury, suit, liability or expense, including the District's reasonable attorney's fees and costs of suit, which may arise in any way in connection with the Student's driving of a motor vehicle to and from golf club activities or while Student is a passenger in a vehicle being driven by another student or adult to and from golf club activities.
