Master in Criminal Justice - Minor in Faith-Based Restorative Justice and Advocacy

HBI University

Course Duration: 2 years

Credit Hours: 69 (including 15 credit hours for minor)



Program Description

The Master in Criminal Justice at HBI University is designed for students seeking expertise in law enforcement, corrections, forensic science, and the judicial system. This program integrates criminology, public policy, and ethical justice leadership to prepare graduates for careers in law enforcement, the court system, corrections, and advocacy organizations.

The Minor in Faith-Based Restorative Justice and Advocacy offers a specialized focus on integrating faith-driven reconciliation, criminal justice reform, and social advocacy. Students will explore faith-based rehabilitation programs, restorative justice practices, and ethical frameworks for criminal justice leadership.

This 69-credit hour program includes 30 credit hours of foundational criminal justice courses, 24 credit hours of core forensic science and legal training, 15 credit hours in Faith-Based Restorative Justice and Advocacy, elective coursework, a supervised practicum, and a research-based master's thesis or capstone project.

Admissions Requirements

- Bachelor's degree in criminal justice, law, sociology, or a related field
- Minimum GPA of 3.0
- Two letters of recommendation from faculty or professionals in law enforcement, criminal justice, or advocacy
- Statement of purpose outlining career goals in criminal justice and faith-based advocacy
- Resume with relevant experience in law enforcement, corrections, or nonprofit justice initiatives
- Interview with faculty committee (if required)

Practicum Requirement

Students must complete a 300-hour supervised practicum in law enforcement agencies, correctional facilities, advocacy organizations, or faith-based criminal justice initiatives. Practicum placements include restorative justice programs, prison ministry projects, and nonprofit legal aid services.

Master's Thesis / Capstone Project

Students must complete either a research-based master's thesis on criminal justice reform, restorative justice practices, or faith-driven legal advocacy, or develop a capstone project implementing a rehabilitation or reintegration initiative for incarcerated individuals.

Program Outcomes

Graduates of this program will be able to:

- Analyze crime trends, public safety policies, and the role of faith in criminal justice reform.
- Develop faith-based interventions for rehabilitation, reentry, and victim restoration.
- Apply ethical and restorative justice frameworks to law enforcement and legal systems.
- Advocate for social justice and policy reforms that align with faith-based values.
- Lead community-based crime prevention and victim advocacy programs.
