

## **Privacy Policy**

This privacy policy applies to the Harvestdeal app (hereby referred to as "Application") for mobile devices, created by Josvigame (hereby referred to as "Service Provider") as an Ad Supported service. This service is intended for use "AS IS".

### **Information Collection and Use**

The Application collects limited information necessary for the functioning and improvement of the Application. This information may include:

- Your device's Internet Protocol address (e.g. IP address)
- The pages of the Application that you visit, the time and date of your visit, and the time spent on those pages
- The operating system used on your mobile device

The Application does not gather precise information about the location of your mobile device.

### **Third-Party Access**

Only aggregated, anonymized data is periodically transmitted to external services to aid the Service Provider in improving the Application and their service. The Service Provider may share your information with third parties as described in this privacy statement.

The Service Provider may disclose User Provided and Automatically Collected Information:
