1)	What is the source system(s) for patient diagnoses?	N/A				
2)	Which patient records will you be sending diagnoses for? E.g. Will you be sending diagnoses for all patients with a PAS record at the trust? Or maybe only for patients within a certain team/speciality?					
3)	Do you intend to send an initial HL7 feed of diagnoses data for all patients in scope?	Ideally all patients in scope should have their diagnoses record updated with all available data, this can then be updated as new data points are added locally.				
4)	Which patients will be excluded?					

	Any specific specialty/team that will be excluded?		
5)	Are you able to send verified national identifiers? Are you NHS SPINE enabled? If not, how do you verify the accuracy of NHS numbers?	All messages require a verified NHS number. This is commonly via the SPINE but some other trusts have their own data quality assurance processes. Status 01 only.	
6)	Are you able to send all diagnoses held against a patient record?	PKB purge and replace all diagnoses data for a patient record sent previously from the sending source. In order to prevent existing diagnoses in the PKB record from being removed, we recommend that the full list of diagnoses are always provided.	
7)	Will you be providing the diagnoses names and codes?	PKB recommends that customers provide both the name (textual description) and code for all diagnoses.	
8)	What are the trigger points in your system that will send new diagnoses to PKB?		
9)	Do you require any Privacy Labels other than General Health to be added to any diagnoses? Diagnoses will default to having the General Health Privacy Labels. Other Privacy Labels available are Sexual Health, Mental Health and Social Care.	Diagnoses can be mapped to Privacy Labels using either Read v2 or SNOMED codes if they are supplied as the Diagnoses Code. Note - This requires extra configuration on the PKB side.	
10)	Will you provide a timestamp for when diagnoses were recorded?	It is recommended a date of when each diagnosis was recorded is provided. This not only provides a useful data point to users, but will also act as an additional parameter to determine if the same diagnoses data has been provided more than once in the HL7 message.	

11)	•	It is possible, but not mandatory, to provide the name (surname as	
		a minimum) of the diagnosing clinician for each diagnosis.
