eSchoolPlus COVID Back to School Guidance and Changes

Based on feedback received over the past several months in our COVID/Support office hours calls, and further detailed discussions with the eSchoolPlus Customer Advisory Board members, the biggest area of need to prepare for Back to School is identifying whether students will be In School Full Time, Virtual Full Time, or some hybrid combination of those options.


Although it is still in development, we would like to provide some information in advance about functionality that will be provided in our July and August Monthly Maintenance releases to assist eSchoolPlus customers with Back to School planning.

#### July Maintenance Release -


#### Learning Location Validation Table and Program Tracked District-Defined page

We will be providing database update scripts in the July 30, 2020, eSchoolPlus maintenance release to create the following for all customers:

• Learning Locations validation table: Use this validation table to define the different types of student Learning Locations for the coming year. Each Learning Location code will define when you can expect to find a student of that type to be In School vs. At Home. Each district can define their own codes, but the learning locations might look something like:



• Learning Locations District-Defined Page: The new page will include a single field to capture the appropriate Learning Location for each student. This new field will be program tracked, so it can change over time and will have a REG-MAINT-PSLL security resource assigned to control access. The screen will look something like this:




By providing the above changes in the July 2020 release, districts can begin defining their codes and assigning them to students as appropriate, while we work on the additional changes.

#### **August Maintenance Release -**

Calendar Modifications and In School/Virtual icon

Although some of the final details are still being worked out, we then plan to include the following additional changes in the August 27, 2020 maintenance release:

• Calendar Day Changes: Modify the calendar detail page to associate the Location Types that are defined as Remote Full Time, In School Full Time, In School AM Only, or In School PM Only for each calendar day. It will look something like this:




- **Indicators for Learning Location:** Display a new icon in key areas of eSchoolPlus, TAC and HAC to easily identify where a student should be on any given day. The actual icon is still in design, but will be able to indicate:
  - Whether the student is expected to be in the building or not today
  - The actual code assigned to the student

It will appear on key screens such as:

- eSchoolPlus Student Banner
- TAC Attendance Entry
- TAC Gradebook
- HAC Banner
- Additional screens as schedule permits

Exact placement and design of icon is still to be determined but might look something like this.



By making the changes described above, you can continue to schedule and take attendance as always, and just utilize these new "Learning Locations" to provide the visual cue on key screens to track where students should be attending from each day. This method also allows you to transition from one scenario to another, should your state provide new guidance as situations get better/worse moving forward. It will only be necessary to update a student's Learning Location, rather than necessitating rescheduling, etc.

#### Positive Attendance Reminder

So, for example, when a teacher is taking attendance, they will be able to view an icon that will identify if a student should be in the building or not that day, so they know whether to expect them in the classroom or if they need to verify their participation via other means, such as attendance via Zoom call (synchronous virtual attendance), attendance via turning in an assignment (asynchronous virtual attendance), etc.

# Summary

As a reminder, you can create additional attendance codes (if you don't already have them), and then make them available in Teacher Access Center so teachers can record the different ways in which a student was verified as present (such as virtual attendance), if your district chooses to implement "Positive Attendance".

#### Disclaimer

Keep in mind that, depending on your state/district requirements, you can add the capability of taking Positive Attendance, but keep your day totals definitions as is, if your state still only requires totals based on absences and tardies. Further guidance specific to individual states will be provided by the compliance team for each state, as necessary.





The steps to set this up are as follows:


 Access the Attendance Codes page to add new attendance codes that capture reasons why a student was considered present



• Modify Attendance Building Configuration to optionally specify a default present code and additional attendance codes that teachers can select from.



- Access the TAC page to:
- View the new icon to determine if a student is expected in the building or not today
- Click A or T column as normal if student is to be in the building today
- Click the P column to mark the student present with the selected default present code
- Select PZ (or other code you've defined in the configuration) in the Code column to mark the student present for any other reason appropriate in your district

  - Oneway salted hash algorithm to encrypt passwords, unable to unencrypt
  - Informational Technote sent on Aug 2 advising customers about this change; follow-up email in draft and will be sent most likely on Monday
