



Unilever FWC26 Release Form 2026 ("Release Form")

This Release Form is between you and Unilever Bangladesh Limited in relation to your participation at **Clear Fest 2026** which will take place in **Kamal Atatürk Park Banani** on **20-22 June 2026** and contains a disclaimer in relation to any injury, damages or other losses you may suffer during The Event.

For the purposes of this Release Form, "Unilever Group" means Unilever PLC, and any company or partnership in which Unilever PLC, directly or indirectly, and from time to time: (a) owns or controls the voting rights attaching to more than 50% of the issued share capital; or (b) controls the appointment of a majority of the board of management).

By signing this Release Form, you hereby acknowledge that you have read, understood and agree to the terms, and that you enter into it freely and voluntarily with full authority to give all assurances, confirmations, waivers and agreements herein.

Disclaimers, Liability and Indemnity

You acknowledge and agree that participation in The Event may include activities that could be hazardous, including but not limited to travel to and from The Event Location, domestic travel within the country where The Event is taking place, transportation by third-party carriers, accommodation, crowd environments, excursions, creative activities, social events and participation in sporting related activities.

You freely assume any and all risks or hazards associated with your participation in The Event including loss, damage, injury, illness, death or liability that may arise from or in connection with The Event, other than any risk or liability that cannot be excluded by applicable law, however caused.

In particular, you agree that:

1. you will listen to, and follow the instructions of, any Event leaders and organisers at all times during the Event, and comply with all reasonable directions and requests from the same;
2. you will comply with any guidelines provided to you by Unilever, The Event leaders or any other third party or authority involved in The Event and all applicable laws in respect of The Event, including all guidelines pertaining to pre-approval requirements for any content created during The Event;
1. you will participate in The Event at your own risk;
2. you will exercise due care and caution while participating in The Event and ensure that you do not carry dangerous or prohibited items to The Event;
3. you will not conduct any third party advertising (including by way of advertising on clothing and/or apparel worn by you at the Event) during The Event without the prior written approval of Unilever;
4. to the extent permitted by applicable laws, Unilever, shall not be liable for any (a) injuries, accidents, damages, losses, or claims that may occur to you during or in connection with The Event; (b) theft, damage, or loss of personal belongings during The Event; (c) injuries or damages resulting from the consumption of food, beverages, or any substances provided at The Event; or (d) special, consequential, incidental, indirect or punitive damages of any kind in relation to your participation in The Event;



5. you will maintain valid and comprehensive medical and travel insurance coverage for yourself for the duration of your participation in The Event. You are solely responsible for any costs and liabilities arising from injuries, accidents, or medical conditions that may occur during your participation in the Event. You further consent to receiving any immediate medical treatment deemed advisable or necessary in the event of an injury, accident or illness suffered whilst attending The Event, where you are unable to provide informed consent at the time;
6. you shall refrain from using or referencing (directly or indirectly) any third party products or brands whilst in attendance at The Event. You further acknowledge that you shall not carry out any commercial or promotional activities unrelated to Unilever brands within The Event premises; and
7. you acknowledge that you may not be allowed to access or participate in The Event if you fail to clear the mandatory security checks.

In addition, you acknowledge and agree that:

1. Unilever may cancel or postpone The Event for any reason and shall (where possible) provide you with as much notice as possible where that is the case. Unilever shall not be responsible for any costs or expenses incurred by you as a result of such cancellation or postponement; and
2. decisions relating to the: (i) logistics of The Event; (ii) venue and facilities to be used at The Event; and (iii) overall operation of The Event, remain, in each case, at the sole discretion of Unilever.

To the extent permitted by applicable laws, you hereby release, indemnify and hold harmless Unilever, the Unilever Group and any of its affiliates, including its directors, officers, employees, agents and contractors (*each a "Released Party"*) from and against any claims, liabilities or expenses of any kind, whether direct or indirect, and from any amount, obligation, burden and / or any other liability or responsibility of any nature whatsoever, arising from your participation in The Event (whether occurring before, during or after The Event), to the fullest extent permitted by applicable law whether caused by any action, inaction or the active or passive negligence of a Released Party or otherwise.

To the maximum extent permitted by applicable laws, the Unilever Group shall in no way be liable to you for any actions taken by any third party (including FIFA or any third party authorised by FIFA).

Nothing in this Release Form is intended to limit liability where such limitation is invalid under applicable law, nor to affect any non-waivable legal rights.

Privacy

I agree that Unilever Group, as the Data Controller, may collect, use, store, and disclose my personal data, including identification data, such as name, date of birth, nationality, photographic identification, contact details, social media handles, images, videos, and other information, for the purposes of organising, managing, and promoting the Event, as well as for any other legitimate business purposes of Unilever Group, for the legitimate and necessary period.

I acknowledge that Unilever will process my personal data in accordance with the applicable [privacy notice](#) made available to me by Unilever from time to time.

Image Rights



I acknowledge and agree that Unilever Group and / or any photographer or cameraman acting on their behalf have the right to take photographs, recordings and film you during The Event and to create materials from such photographs, recordings and film.

You hereby grant to Unilever, the Unilever Group and their respective partners and agencies an exclusive, perpetual, irrevocable, royalty-free, worldwide, sub-licensable right to use, reproduce, exploit, modify, alter and/or integrate with other materials your Image Rights (including your name, image, likeness, voice and appearance) as captured during The Event in any media for the promotion of Unilever, its brands and products and in connection with The Event.

For the avoidance of doubt, Unilever and the Unilever Group shall be entitled to make edits, cut-downs, adaptations and alternative versions of such materials and to use such materials for marketing, advertising, publicity, internal, archival and industry award purposes without further approval from you.

I acknowledge and agree that I shall not be entitled to any further payment or compensation in respect of the use of such Image Rights.

Order of Precedence

In the event of any conflict, inconsistency or ambiguity between the terms of this Release Form (including, without limitation, the provisions relating to disclaimers, liability, indemnity and assumption of risk) and the terms of any other agreement, arrangement or understanding (whether written or oral) between you and any member of the Unilever Group and/or any third party agency engaged in connection with The Event (including any engagement, influencer or content creation agreement), the terms of this Release Form shall prevail to the fullest extent permitted by applicable law.

Miscellaneous

You shall not disclose without Unilever's prior written consent any confidential information that you may receive as a result of your engagement under this Release Form, including details of this Release Form, save as required by law, a competent jurisdiction or any governmental or regulatory authority, or to your professional advisers. A disclosure by your professional advisers shall be deemed a disclosure by you.

This Release Form is governed by and construed in accordance with the laws of Bangladesh, and any disputes arising from or in connection with this Release Form shall be subject to the exclusive jurisdiction of the courts of Dhaka, Bangladesh.

This Release Form constitutes the entire agreement between the parties in relation to its subject matter and supersedes all prior discussions, negotiations or agreements.

If any term of this Release Form is found to be invalid or unenforceable under any applicable law, such term shall, insofar as it is severable from the remaining terms, be deemed omitted from this Release Form and shall in no way affect the legality, validity or enforceability of the remaining terms.
