Read carefully, by commissioning me you agree to these terms.

General terms

- 1. I reserve the rights to refuse a commission if I deem it reasonable.
- 2. I have the right to refuse doing any work or changes I'm not comfortable with.
- 3. It's not allowed to use any of my work for commercial purposes.
- 3.1. Streaming uses are allowed. (i.e. Youtube, Twitch, Picarto)
- 3.2. Reselling is not allowed.
- 4. At certain points of progress through the commission, a message will be sent showing it and I will halt work for up to a day or until the progress is approved.
- 4.1. If the commissioner doesn't respond within that day, I will continue work. If the commissioner later wishes to make changes that pertain to that specific approval phase, the changes may apply additional charges.
- 4.2. When stating any changes at the approval phases, try to be as descriptive as possible. This is to avoid making me do a lot of repeated changes which may apply additional charges.
- 5. If the commissioner won't be available to respond to messages for a long period of time, it's best if they warn me as to not waste time waiting for approval, or they can choose to put the project on hold until they're available again for the approval phases.
- 6. The **approximate** time of delivery will vary per individual project, increases with each change request, and will be displayed on their respective card in the <u>Trello Board</u>.
- 7. For NSFW commissions the commissioner must be 18 years old or older.
- 8. Please credit/link my work if asked or reposted anywhere.

3D Commissions

- 1. I reserve the rights to use commission models publicly (i.e. model examples, exposition, portfolio), unless explicitly defined otherwise at the time of commission.
- 2. All of my work's files and/or assets are to be kept as private as possible. Sharing them is forbidden. (For example VRChat cloning, unitypackage sharing)

Payments and Refunds

- 1. Payments are done through Paypal and must be **paid upfront** before I start any work.
- 2. The currency for payment is **USD**.
- 3. A full refund (minus Paypal fees) is only accepted if I have not started work on your commission.
- 4. A partial refund is only allowed if the commission is cancelled. Only screenshots will be given, not files. The refund amount will depend heavily on how much I have progressed on your commission.
- 5. A full refund will be given if I am unable to continue working on the commission.
- 6. Extra work needed to be done that is not properly stated before payment will be charged.

I currently do not make human characters as commissions.

Don't ask me to make stuff appear super realistic, I do stylized work only. 3D only:

I currently do not make outfits or clothing pieces.

I do not make models with multiple limbs (2 heads, 4 arms, etc).
