

TERMS OF SERVICE (EN)

▣ **What can i do?**

- Anthros and Ferals

▣ **What I won't do:**

- Cub;
- Political or religious illustrations;
- Drawings with offenses of any kind;
- Drawings with themes of sexual abuse, pedophilia or zophilia.
- Mecha

▣ **Extra taxes**

- More than one character;
- Complexity (wings, cloth, etc);

!! ATTENTION !!

Until I find another way to receive my payment, an *extra fee* will be charged to cover the high exchange rate of paypal which is 5,00% (of total value) + 0,50 USD. As example if you commissioned me an art that is 100 USD, the final price will be $100 + 5,00\% + 0,30 = 105,30$ USD

□ **General Rules**

- 1) The Artist won't accept racist or offensive drawings;
- 2) Displayed base prices are subject to change according to the complexity, difficulty, size and medium of each individual piece;
- 3) Clear and concise visual references and/or description of a commission idea must be provided by the client. After which a preliminary quote will be provided by the Artist.
- 4) If your reference was unclear to start with, then you are not allowed to do minor changes without a fee. Make sure to be clear in your order!
- 5) Payments are accepted in **USD only**, through **Paypal**. The Artist will not accept payment in any other form.
- 6) The client has no right to cancel or demand a refund from the Artist under any circumstances after payment is received, so be sure that you want the service;
- 7) The Artist reserves the right to refuse your request without having to explain the reason;
- 8) The Artist reserves the right to cancel a commission and issue a refund due to poor communication, inappropriate/rude behavior or unforeseen inability to complete the commission;
- 9) Client will have the opportunity to direct alterations of the work during the sketch/thumbnailed stage (Max up to 3). Changes after painting starts will not be accepted! Requested revisions that diverge from the client's original commission description/references may increase the length of time a commission takes, and will be billed separately. Minor revisions can be made after the commission is completed. (I will do everything I can to make the customer happy, however after the commission is advanced, like painting or lineart, only really small changes are allowed to be made, such small coloring mistakes);
- 10) The Artist reserves the right to reject critique and redline pertaining to artistic skill or style preference (i.e. anatomy, coloring style, etc.) or if said critique reduces the artistic quality of the piece;

11) The Artist ensures the client will receive email or message updates on commission when necessary. The predefined deadline is three weeks, but you will always be notified of the progress and a possible delivery date;

12) Communications about commissions between the client and artist will take place through Telegram (@suky) or Discord (sulky). (Telegram and Discord messages will be screen captured for the purpose of record-keeping);

13) Payment must be made after the client approves the sketch sent by the Artist. In high payments, the client may pay half beforehand and half after receiving the finished piece;

14) The Artist retains ALL the rights to the commissioned artwork, including the right to make prints and merchandise, and to alter the commissioned work to make it more generic for print at the Artist's discretion. Image rights can be negotiated for an added fee.

15) The Artist retains the right to display all commissioned work on any personal website, gallery, journal and to promote itself in any place or site;

16) The client retains all rights to their respective characters.

17) Clients may also resize or crop the artwork to create icons, wallpapers, or other graphics to be used in non-commercial digital format, but the client cannot alter the artwork itself. The client may also upload the artwork to their personal website or gallery accompanied by a credit line to the Artist, with the Artist watermark.

18) The client may not profit from the artwork/ reproduce/using the copyrighted artwork commercially (meaning cannot make Money of it in any way);

19) The Artist may recycle sketches and preparatory works that were rejected by the Commissioner for other commissions or personal works.

20) In the event that a client is unreachable by ordinary contact means (email/Telegram) for 3 months or more, the Artist reserves the right to cancel the commission and retain a 10% fee. The client is welcome to receive credit valid toward another commission at the Artists current rate (having rescinded their spot in line due to lack of communication). If the client is unreachable for 1 year or more, then the payment is void;

21) The Artist may not be available to answer emails on holidays, scheduled days off work, or emergencies. If you do not receive a reply within 7 days, I encourage you to resend your message;

22) The client has 24 hours to confirm the invoice payment, otherwise it is canceled and the client is added to the low priority list;

23) All drawings and designs may or will include a subtle sign that you may not remove, unless you need to crop for avatar/icon usage.

□ **Payment**

The client must make payments in USD via paypal invoice full upfront within 24 hours upon receiving the invoice to continue. ***Otherwise, refer to section 22 above.***
****Prices are subject to change without notice.***

□ **Regarding age**

The client is 18 years or older to commission the artist for a nude artwork. Any disregard of this results in a temporary ban and the client is added to the low priority list.
