Name of Course: Not-for-Profit Taxation

Catalog Description: This course provides a comprehensive grounding on key tax and compliance requirements for tax-exempt, not-for-profit entities. It includes real-world examples and case studies. Topics include qualifying for and maintaining federal tax-exempt status, the unrelated business income tax, private foundations, and charitable deductions.
