# Public session and Item 35.19 Boundary Commission recommendations re review of Wiltshire Council

Cllr Richard Clewer will be present to answer questions about the Boundary Commission's proposals, and Wiltshire Council's response, which was agreed at an extraordinary Full Council meeting on Monday. Essentially, as I understand it, Wiltshire Council proposes that Pitton & Farley civil parish remains in the Southern Area Board area, and becomes part of a new Alderbury & Winterslow ward - in other words, no connection at all with Laverstock & Ford civil parish, nor with the Salisbury Area Board area.

# 36.19 Highways matters

- a. Tasks for the Parish Steward/additional funding I have circulated a list of tasks that Wiltshire Council is happy to undertake, now that it has additional government funding available to it.
- b. *Metro data* I have sent e-mails requesting the underlying statistics, and have telephoned with no response I will now undertake an FOI request.
- c. *Speeding public meeting* this has been organised by Cllr Fry for Wednesday 10th April at 7.00pm in Pitton VH.

Please note that the CATG meeting scheduled for Wednesday 3rd April has been cancelled due to lack of sufficient business. The next one is scheduled for Wednesday 19th June at 6.30pm at Bourne Hill.

WC Highways hold its annual meeting in Salisbury on Wednesday 8th May at 7.pm, venue t.b.c.

Wiltshire Council has resurfaced White Hill in Pitton almost from top to bottom, which should enable the red rubble strips to be installed in the next financial year. The C321 Between the two villages has been extensively patched in places, as has Parsonage Hill in Farley.

  used to establish where and what should be built and for whom, plus a presentation
  on the Highways maintenance programme for 2019/2020. The next meeting is on

- Clarification re status of Aymers Pond I have contacted WALC about this, and am awaiting its response.

- a. *RoSPA report* the play area enclosure boards need repairing. I will ask George Manston if he can do this.
- b. Banking additional signatories and internet banking the variation to the mandate
  has been sent to Lloyds, and I am awaiting confirmation of the additional signatories.

- c. New parish council website Ged will update.
- d. Farley phone box Ged has chased this. The date of 31st March by which the box would be moved was a provisional one, and subject to change. I suspect the Council will need to keep up the pressure.
