Transforming Augmentation aggregate records Introduction

In a file of approx. 113K records that were randomly pulled from the LC April 2022 file of approx. 5.6M records (new and modified), 86% were pulled as either describing:

• Collection works: fewer than 1%

Diachronic works: 19%Aggregate manifestations

o Collection aggregates: 25%o Parallel aggregates: 1%

o Augmentation aggregates: 42%

This means that if we only transform records for non-aggregates, we will only be working with 14% of the database.

I originally thought that we could easily include <u>Augmentation aggregate manifestation</u> (AAM) records in Phase I, under the assumption that the MARC data in an AAM record would bhttps://access.rdatoolkit.org/en-US_ala-bd1f1ef9-978c-34ee-8881-acc1500130b9/p_gsw_qqz_rdbe describing the single augmented work, except for some of the subject headings provided.

Once I looked more closely at the file of AAM records, however, I found that the records carry data that describes both the augmented (primary) aggregated work and expression and the augmenting (supplementary) aggregated works and expressions, with no programmatic way to distinguish which works and expressions are being described by which data. For example:

It seems, therefore, that the only safe thing to do is to map all of the work and expression data from an AAM record to the augmentation aggregate manifestation and aggregating work, and only some very limited specific data to the augmented aggregated work.

Recommendations

Here are my suggestions.

Manifestation data

- o All Manifestation attribute data is mapped to appropriate manifestation elements
- o All Manifestation relationship data is mapped as per the Agent Relators Table.20240409

MAIN Work and Expression data:

- o Add Category of work:
 - for aggregating work: Aggregating work DONE

Unless Work data is specifically attributed to the augmented aggregated work (possibly using subfield \$3?):

Map appellation data

Access point data:

- for aggregating work (whether a 1XX/24X headings field contains only work elements or contains work elements + expression elements):

Map attribute data

- For aggregating work:
 - All work <u>and expression</u> attribute data <u>and Place and Timestamp data</u> is mapped to the aggregating work (see <u>Work data mapped to Aggregating work</u> and <u>Expression</u> <u>data mapped to Aggregating Work</u> and <u>Expression data mapped to Note on work</u>), from:
 - o the body of the record
 - o and from a main entry work or expression field
- For augmented work and expression
 - Work and expression attribute data:
 - o is mapped, as appropriate) to the augmented work and expression from a **main entry** work or expression headings field
 - o is only mapped from the body of the record for:
 - AP for work; AAP for work; Title of work; Preferred title of work; plus any qualifier data
 - AP for expression; AAP for expression; Title of expression; Preferred title of expression; plus any qualifier data

Map Primary relationship data:

- for aggregating work: Manifestation work manifested / manifestation of work
- for augmented work and expression:
 - Manifestation: expression manifested / manifestation of expression
 - Expression: work expressed / expression of work

Map Secondary Agent Relationship data:

- For main entry (100-111) Agent data:
 - to the aggregating work:
 - o if the relationship is from the <u>Agent Relators Table.20240409</u> and is *aggregator* [Agent] or compiler [Agent] then map it as such
 - o if it is not aggregator or compiler or is not from the table, then map it as:
 - Work related [Agent] of work
 - and Manifestation: contributor [Agent] to aggregate
 - o to the **augmented** aggregated single work

- if the relationship is from the <u>Agent Relators Table.20240409</u> and is NOT aggregator [Agent], map as appropriate
 - if the relationship from the <u>Agent Relators Table.20240409</u> IS aggregator [Agent], do not map the data to the augmented work
 - if the relationship is not from the table or no relationship is provided, map as Work: related [Agent] of work
- For added entry (700-711) Agent data:
 - to the **aggregating** work:
 - o if \$e is "joint aggregator" or "jt. aggregator", then map as as aggregator [Agent] (or compiler)
 - if not and maps to work or expression property, then map as: Manifestation: contributor [Agent] to aggregate
 - if no relationship information is provided, then map as: Manifestation: contributor [Agent] to aggregate
 - to the **augmented** aggregated single work:
 - do not map any added entry related agents to the augmented single work
- For added entry (7XX not I2=2; 8XX) WEM data:
 - to the manifestation:
 - o map as per the <u>WEMI Relationships Table.20240525</u>
 - to the **aggregating** work:
 - o map as Work related work of manifestation [rdam:P30265]
 - o to the **augmented** aggregated single work
 - do not map any added entry WE relationship to the augmented single work

Map Concept data:

- from subject heading fields, to the aggregating work only
- from classification fields, to the aggregating work only (even though most will actually apply to the single augmented work)

Decisions

Outstanding questions

Questions that are raised by this process and still need to be discussed by the wider community

- When does a series statement found on a manifestation relate to the primary augmented expression/work vs. the aggregating work?
- While still in MARC, how can we make it clear (mark) which data elements relate to the primary augmented expression/work vs. the aggregating work?
 - If all of the data elements relate to the primary augmented expression/work do we need to mark those elements (to be safe)
