### **Item 7: President's Report**

- Executive Reports
  - President, Francesca Lepore
    - In the early fall, acknowledging the social outreach work that CASG has done to spread awareness and get involved. The two main events were fall orientation and Fall Expo.
    - She explained the Syablis Initiative which is to post past syllabuses when one is registering for the course. She also conducted the student survey to see if the population was interested. She will be meeting with the university affairs committee. The goal is for this to be implemented universally throughout all departments.

### **Item 8: Vice President's Reports**

#### **Item 8a:** Vice President Internal, Allan Buri

- Discussed what positions were hired.
- Hired coordinators and equity officers.
- Reinstated and revised contracts that have not been done for several years.
- Allan proudly expressed the amount of electron interest tripled from last school year - the amount of counselors went from 16 to 44. This was mainly accomplished through outreach from fall orientation and Expo.
- Tasks to be focused on are policy review for CASG, specifically the proxy policy. Also to implement routine disclosure policy to enhance transparency. Also, creating an easier hiring experience for future executives. In addition, to have more accountability with counselors' involvement in different committees.

#### **Item 8b:** Vice President Operations, Chris Pratt (he/him)

- Google suite fees have reached the end of discounted trail, so they were going to get more expensive.
- Chris was looking into Tech Suite, to get free software. He estimated to save \$600-700.

- When seeking to approve this, an email from Carleton stated "Carleton cannot leverage its charitable status to help CASG in this manner" in an email.
- He proudly announced that AIF (Academic Incentive Fund) which gives money to academic societies opens today, up to \$450 funding.
- He gave \$1700 sponsorships to the academic society in September. In doing so they had such events as Hackathon and biochemistry orientation.
- He is getting ready to set up a team Canvo pro account for academic societies. The cost is \$75 fee per year.
- AIF provided several scholarships and nearly \$12,000 worth of funding, and the majority of CASG's funding went back to students.

**Item 8 c:** Vice President of Academic, Nora Draper

- Nora worked on a survey to the student population for the Syablis Initiative and provided communication to administrators.
- CASG is launching its first equity week event. Its target is any student running academic events. A panel event will take place, October 17 at Tory 240, 5 pm - 7 pm where experienced students will be on the panel.
- CASG is also doing midterm study snacks after reading week.
- Also another event is the Student Senators Network so they can meet and have targeted goals
- She is planning in the winter semester to improve scholarships for community involvement and academic achievement.
- CASG is having its first bursary, which would be needs based.

- In the summer, they planned and implemented more CUSA jobs for students.

- He is negotiating a health and dental plan to reduce it by \$40.
- He focused on more funding for immediate housing support for students with various circumstances including who have been sexually assaulted.
- CUSA was more involved in Fall orientation events than previous years.
- For the goal of more transparency for students, they are creating an executive road map which includes their goals, visions and progress. This is to hold them accountable. This extends to service centers and businesses.
- They are also planning and completing the Haven Connect Coworking space and opening The Wing.
- They have been applying for grants with the government.
- They recently launched a new CUSA clubs website.
- They have been focused on increasing engagement with social media.
- They have been involved in community efforts for panda game safety
- They have engaged in Capital pride.
- They will have an October bi-election.
- They are hoping to get \$2.98 in tuition for the Food Assistant Program.
- They want to expand food hamper service.
