Sub-primer of the U.S. Department of Agriculture (USDA)

I. Background Information:

The Animal and Plant Health Inspection Service (APHIS) is a relatively new Agency, established in 1972, and consolidating USDA's earlier animal and plant health bureaus. Its mission is to protect America's animal and plant resources from agricultural pests and diseases. This includes protecting and promoting U.S. agricultural health; regulating genetically engineered organisms; administering the Animal Welfare Act (AWA); carrying out wildlife damage and disease management activities; and protecting public health and safety and natural resources from invasive pests and pathogens.

APHIS develops and advances science-based standards with trading partners to ensure America's agricultural exports, worth more than \$50 billion annually, are protected from unjustified restrictions. In the event that a pest or disease of concern is detected, APHIS implements emergency protocols and partners with affected States to quickly manage or eradicate the outbreak.

APHIS' Animal Care program enforces the AWA and the Horse Protection Act. The AWA covers warm blooded animals used in research, bred for commercial sale, exhibited to the public, or commercially transported, and requires minimum standards of animal care to be established and enforced.
